The Quality Inn was very accommodating and the food was bountiful.


Thank you, Jean, for all you did. Congratulations are in order for Dusty Lathrop. While she was in E. City a Great-Grandbaby was born.

CHAPLAIN'S CORNER



ONCE A SUBMARINER...!

Saturday night, March 20, we received a phone call from SubVet Bill Lowe. A neighbor had just told him that there would be a memorial service the next day in Raleigh for a North Carolinian who had lost his life aboard the Confederate submarine HL HUNLEY in February 1864. A flurry of late-night phone calls resulted in six North Carolina submariners gathered for the service the following afternoon. Joining Lowe and your Chaplain were Bob Govern, Dick Kanning, Wayne Powell, and Ken Sigworth, their colorful vests standing out in sharp contrast to the drab Confederate-uniformed soldier and sailor and black-clad mourner enactor who escorted the remains of Boatswain's Mate James A. Wicks.

From the lying-in-state in the rotunda of the North Carolina Museum of History to the return of his remains to the vehicle awaiting the return trip to Charleston, the service was tastefully somber and appropriate. Listening to the eulogy, we feel certain that none of us submariners felt anything but a closeness, a brotherhood with Boatswain Hicks. A series of "Thank you for your service" handshakes offered by an onlooker led us to understand that our service, like Wicks', was, except for the 140-year time lapse, comparable and equally important and appreciated. We could not but relate to the occasion the 2nd line of the traditional Doxology, "Praise Him, all creatures (all submariners) here below." We could not but imagine Wicks and his seven HUNLEY shipmates looking down from "above," smiling at each other knowingly, and whispering, "Thank you for remembering us." We could not but imagine the feelings of the HUNLEY crew in those last moments: Feelings of fear--"I sought the Lord, and He heard me, and delivered me from all my fears." (Ps. 34:4.)

Feelings of threatening disaster--"I called upon the Lord in distress: the Lord answered me, and set me in a large place." (Ps. 118:5.)

Feelings of facing a crisis--"Let us therefore come boldly unto the Throne of Grace, that we may obtain Mercy, and find Grace to help in time of need." (Heb. 4:16.) Feelings of weariness--"Come unto Me, all ye that labor and are heavy laden, and I will give you rest." (Matt. 11:28.)

Our major regret was that the local news media chose not to give the memorial sufficient coverage to permit a larger turnout. This regret was voiced at the Museum before the service. It was not until a full week later that a Dennis Rogers column entitled, "Hunley Crewman Our Own," and a picture of the enactors appeared in print locally. Your Chaplain took the liberty of e-mailing columnist Rogers, expressing thanks for the column, but expressing regrets of its poor timing. Rogers' e-mailed response was a terse, "...glad you liked the column. I, too, wish I had known about it in time, but the information didn't get to me until the ceremony was over."

We advised Rogers of the memorial service and interment of the eight HUNLEY crewmembers in Charleston on April 17, and expressed the hope that the April event would be given more prompt and complete coverage by the local press.

After all, this is part of the history of the United States of America.

On page 6 is a good picture of Pete and Carpathia Sococo of the Tidewater Chapter. The picture was snapped at Kings Bay in November. We take this means of expressing the condolences of North Carolina submariners to Pete on the passing of Carpathia March 13. We feel particularly close to Pete, since he and I both served aboard BRILL.

You know the old saying, "The husband's always the last to know." Well, that's how we felt when we turned to page 11. The entire page was devoted to the January 23rd Golden Anniversary of Oliver and Terry Thompson. Yes, OUR Oliver and Terry. It included a picture of the couple in their festooned-for-the-occasion home. We won't try to describe the goings-on here: read the full account for yourself, then show it to your kids (if you want to make them feel bad about not doing something similar for you).

We stopped again at page 18. It was a full page article by John Marc Harina (an SSBN622 sailor) on North Carolina's submarine memorial in Burnsville. It told of our dedicating it on June 7, 2003, and gave directions to Moonshine Mountain for those desiring to eyeball the handiwork of GATO sailor Harrell Flowers. Again, read the full account for yourself. You'll not regret it.

Our congratulations to Dolphinette Editor Gloria Unrein of Denver, CO. Keep up the good work: you have more than your share of male readers.

THE BINNACLE LIST

We regret having to report our folks on the Binnacle List, but that's life. We like it far more to be able to report the names of those feeling better. At our successful meeting in Elizabeth City, we were delighted to welcome the Morrises-Bill just a month after open heart surgery and Deane after a bout with pneumonia (Deanie's major complaint was cabin fever). The weather helped us all out of the doldrums--it was the first meeting E-C meeting in years when the pool was uncovered. We sadly reported the passing of Ben Grimes on February 16--we attended his services and delivered a bronze marker and Book of Memories to widow Ruth.

But we do understand as do the families of sailors who paid the ultimate price aboard the submarines: DORADO--sunk by friendly aircraft; TULLIBEE--sunk by own torpedo; SEAWOLF--sunk by friendly destroyers; and TANG--sunk by own torpedo. Our prayers to families of all submariners--past, present, and future.
