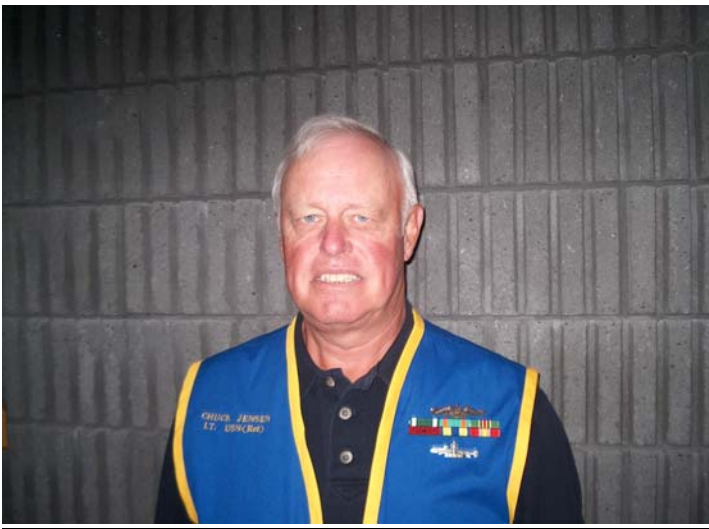

Shipmates,

I hope everyone had a wonderful holiday season and I am looking forward to being your base commander again during 2005. In addition to myself, our other elected and appointed base officers remain the same from last year.

I view 2004 as a successful year for the base and would like to review some of the significant activities that were accomplished this year:

- 1 In May, we hosted a joint USSVI District #3 and WWII Southeast Region meeting in Salisbury. It was great to see all the WWII and USSVI folks get together and swap sea

stories. From the conversations I had with many of the attendees, everyone had a good time. The closing luncheon catered by Gary's Barbeque at the NC Transportation Museum was by far the highlight of the meeting. A great deal of credit for this successful meeting goes to Dick Kanning and his planning committee that included Bob Hopkins Sr., Robert Hopkins, Don Small, and Bill Bradburn. Also I can't forget to mention Carol Hopkins who took care of the ladies on their shopping trip to town and Will Harvey who kept the drinks flowing in the hospitality room as our duty bartender.

- 2 In September, some of our base members participated with our parade submarine in the parade during the USSVI National Convention that was held in Saratoga Springs, NY. In addition to Saratoga Springs, we used the submarine in parades during the year at Thomasville, Greensboro, Asheboro, Charlotte, and Wilson. Also in conjunction with the Greensboro parade, some of our members participated at a book signing by Ken "Pig Pen" Henry the author of the Gallant Lady a biography of the USS Archerfish. Our parade submarine parked outside of Barnes & Noble (the location of the book signing) drew a lot of attention from shoppers passing by.
- 3 Also just before the USSVI National Convention Don Small and I signed the U.S. Submarine Veterans of North Carolina (NC Subvets) Charter that combines the USSVI Tarheel Base and the WWII Tarheel Chapter at the state level. Dick Kanning along with Bill Whelen and others developed this charter. While at the USSVI National Convention, Dick and I attended the National Board Meeting where Dick discussed our new NC Subvets Charter. The board will make it available as a model for other bases to use when considering becoming a joint organization with a WWII chapter at a local level.

- 4 Once again Mike Burkholder did an outstanding job in planning and setting up our annual Pearl Harbor Meeting. Our guest speaker this year was Cmdr. Scott Waddle (ret.) former skipper of the USS Greeneville and author of the book "The Right Thing". Scott gave a very inspiring talk about the events before and after the collision of the USS Greeneville and the Ehime Maru. He is one of our new members this year.
- 5 Speaking of members, our base membership continues to grow having reached a milestone of 115 members by year's end. Also this year we have our first Associate Member (Barbara Dixon) and first member still on active duty (John Gary).

This June we will be meeting again in Burnsville. We skipped having a June meeting last year since in May we had hosted the joint meeting in Salisbury. That is the main reason that I have scheduled a working meeting on Saturday February 12th in Cary from 1130 to 1430. The meeting will be held again at Errico's. Bill Whelan has reserved a room there for our meeting. Errico's will have a buffet - pasta, pizza, full salad bar, and soft drinks for the cost of \$10.00 (includes tax and tip). For base members who have not met there before, the following are directions to Errico's located at 132 Kilmayne Drive:

- 1 Traveling I-40 east use exit 287, right on to North Harrison Avenue at bottom of exit ramp or traveling I-40 west at bottom of exit ramp left on to North Harrison Avenue. It becomes South Harrison Avenue after crossing Chapel Hill Road (NC 54). Left on to Dry Avenue then right on to Kildaire Farm Road. 1st right after crossing SW Maynard Road is Kilmayne Drive. Errico's is on right in a strip mall.

We will again use the Nu Wray Inn in Burnsville as the location for our meeting. Joe and Susan Martin have been in contact with Rosemary (the inn's owner) and she is reserving a block of rooms for us. Also Rosemary will do the luncheon for us at the inn.

Susan will let me know what the room rates will be, and as soon as she provides this information, I will send it out. Dick Kanning will have the lead in the planning the activities associated with the Chief Flower's Memorial located on Moonshine Mountain just outside of Burnsville. He will be needing some volunteers from the base to assist him with this project

I will continue to use our base communication contacts for those members not having email. I hope we are getting the word out to everyone in a timely manner. Remember it is very important to notify Bob Werner or myself whenever you have either an email or mailing address change

CHAPLAIN'S CORNER



"The Right Thing"

Where better to be at the end of one year and the start of the next than, not in The Chaplain's Corner, but in The Lord's Corner, reading from His Book, doing The Right Thing. Psalm 32:8 provides an answer to the question, "What is the right thing?". "I will instruct thee and teach thee in the way which thou shalt go: I will guide thee with mine eye." Obviously, where we're going to begin this Corner is to Greensboro on Saturday, 4 December 2004, to the North Carolina Submarine Veterans' annual Pearl Harbor Memorial Meeting. It was an impressive meeting. After months of anticipation, we finally got to meet and listen to pearls of wisdom from Scott Waddle, the keynote speaker of the evening. We lost count of the number of SubVets who lined up for the impromptu "The Right Thing" book signing that developed after Scott let it be known that he would welcome the opportunity to do so. Randy Denson led the "parade." We were impressed at the spontaneous standing ovation accorded to Scott following his speech. However, we can't really classify Scott's shared thoughts as a speech or an address: most of us were listening to a shipmate, baring his soul about personal reactions during and following the GREENEVILLE experience. In essence, we were exposed to "The Gospel According to Scott." Want a sample of Scott's Gospel, a most fitting lesson for life? Check out a passage, starting on page 239 of "The Right Thing." It goes: "God has...given me great compassion for others whose lives have been torn apart due to some unexpected nightmare, whether because of a national tragedy, such as the 9-11 attacks, or a personal tragedy, such as the death of a loved one, divorce, bankruptcy, getting fired, laid off, downsized, or replaced. When it's your world that crumbles, it doesn't matter how

big the calamity was that caused it. Regardless of what you are facing, you can make it through. The Bible says, 'No temptation has overtaken you but such as is common to man; and God is faithful, who will not allow you to be tempted beyond what you are able, but with the temptation will provide the way of escape also, that you may be able to endure it' (1 Corinthians 10:13). That doesn't mean that tough times won't come your way. It simply means that no trial can shake you. There's no test you cannot pass with God's help. God will give you the strength. You can hold your head up high. You can do the right thing."

Pearl Harbor Memorial Meeting--Tolling of the Lost Boats

There was the spacious, but crowded, dining room, lighted by only 53 tiny candles.

There was the brand-new ship's bell, courtesy of Dick Kanning.

There was Don Small explaining the traditional tolling of the lost boats ceremony.

There was Shorty Lebonville reading the names (and related where, when, and how) of the 52 submarines lost during World War !!, as well as those lost since then.

There was Bill Morris, punctuating the names of the lost boats, tolling the bell for each lost boat.

There was the steadily darkening dining room as one candle was extinguished after another as each lost boat was tolled.

There were a few SubVets momentarily rising to their feet in memory of lost boats on which they had served, each no doubt still commenting to himself, "There, but for the Grace of God...."

There was the utter and complete darkness and silence as the last boat was tolled and the last candle was snuffed out.

We Had a Dream

We're not certain why, but we seem to be having more and more submarine-related dreams lately. Maybe the aging process has something to do with it. Or maybe not.

Anyway, there we were at the traditional North Carolina Submarine Veterans Pearl Harbor Memorial Meeting. We recognized the occasion because our lone Pearl Harbor Survivor Jim Harbin was there, sitting beside us. His shipmates were ribbing him unmercifully about having been on a tramp steamer in Pearl Harbor when all the fireworks started. Jim was basking in his once a year spotlight, smiling like a Cheshire cat, and calling all of us "Boots." All of us, except Howie Rice, that is, who has probably wrung more water out of his socks than...well, you know the rest.

But back to our dream.

Shorty Lebonville had just read the 33rd lost boat: "S-28--sunk, cause unknown--4 July 1944--all hands lost."

We heard no scraping of pushed-back chairs, and no rustling of men rising to their feet. But, in the dimly lit (by now) dining room, we saw a group of men, mostly smiling,

youthful, mostly dressed in tattered dungarees and denim shirts, with white hats perched cockily on their heads (six were in khakis). They stood silently. Looking more closely, we finally recognized one of them. He was older than the rest and dressed differently. He was in civvies and wearing a colorful SubVets vest. He was S-28 sailor Alfred Wood of Charleston. We remember meeting him when he was our guest at the Nags Head Regional in May 2000.

As we momentarily caught his eye, questioningly, Al smiled, looked at the rest of us who were seated, and said, "My 50 shipmates, who were aboard the S-28 when she went down with all hands, asked me here tonight to speak for them. They're grateful that you haven't forgotten them.

They have just one request: when your memorial is completed in Burnsville, be sure that there's special mention of the S-28. You North Carolina SubVets should be proud: you are being true to your creed."

Then they were gone--as silently as they'd appeared. Only Al Wood remained with us.

As soon as we could, we checked our SubVets creed.

There were the words that spelled out our reason for existence: "To perpetuate the memory of our shipmates who gave their lives in the pursuit of their duties while serving their country."

Our reaction to rereading our creed? The obvious question: What can we do to better perpetuate that memory of our shipmates? The obvious answer: Do the right thing.

Like we said, We had a dream. And, oh, yes, we had phoned Al Wood in Charleston the day before to wish him a Happy, Healthy, and Prosperous New Year.
