### The U.S. Navy answers the question: "Why did the chicken cross the road?

- Naval Education and Training Command (NAVEDTRA): The purpose is to familiarize the chicken with road-crossing procedures. Road-crossing should be performed only between the hours of sunset and sunrise. Solo chickens must have at least three miles of visibility and a safety observer.
- Bureau of Naval Personnel (BUPERS): Due to the needs of the Navy, chicken was involuntarily reassigned to the other side of the road. ## A LITTLE KNOWN VETERAN BENEFIT Provided By Ray Fritz

## "Aid and Attendance"

Regardless of your personal status, consider passing this along to all veterans, families of veterans or individuals with veterans in their family.

"Aid and Attendance" is an underutilized special monthly pension benefit offered by the Veterans Administration for veterans and surviving spouses who require in-home care or live in nursing homes. To qualify, a veteran (includes the surviving spouse) must have served at least 90 days of active military service, one day of which is during a period of war, and must be discharged under conditions other than dishonorable.

The veteran's benefit is \$18,234 annually (paid monthly) and increases to \$21,615 if a veteran has one dependent. The surviving spouse alone is \$11,715 annually. For more information, call 1-800-827-1000

A little-known veterans' benefit for long-term care expenses is available to wartime veterans and their spouses. But the benefit is being overlooked by thousands of families, industry observers say.

The Special Pension for Veterans' Aid and Attendance pays up to \$1,644 a month, \$19,736 annually, toward assisted living, nursing homes or in-home care for veterans 65 and older who served at least 90 days and one day during wartime - stateside or overseas. Veterans and their spouses can receive up to \$23,396 annually and spouses of deceased veterans, \$12,681. Yet, an estimated \$22 billion a year goes unclaimed, said Don Soard, a volunteer with Operation Veteran Aid in Oklahoma City.

In 2007, only 134,000 seniors nationwide received the benefit, which was established in 1952. "Literally hundreds of thousands don't even know about it," Soard said. "Due to incomplete information, many disqualify themselves on income or assets or find the paperwork too burdensome."

Streamlined process-Soard helps families complete the necessary forms, so that approval comes in four to six months. The process is streamlined for vets who are blind or have memory issues and widows with medical needs, he said. Most applicants qualify and payments are retroactive, Soard said. The few who are denied on excessive liquid assets can seek financial advice to qualify, he said. Soard started his volunteer mission two years ago, following the deaths of two family members who served in WWII. "If they'd known about this benefit, they'd have a much better quality of life in later years," he said. "Without it, many vets are forced to go on Medicaid."

Oklahoma is one of nine states where the welfare program doesn't cover assisted living costs. Assisted living often can be an alternative to a nursing home when 24-hour skilled care is not an absolute need, said Willie Ferguson, executive director of Legend at Rivendell in Oklahoma City. "But if someone just has Social Security and a small pension, it's not enough to live here," Ferguson said.

According to a 2008 MetLife survey, assisted living in Oklahoma averages \$2,346 a month, while nursing homes cost \$153 a day for a private room. Of 73 Legend residents, nine receive the veterans' special pension, including Tom Bowen, 77, of Moore. Until I toured this operation, I had no idea the benefit was available," said Bowen, a retired engineer technician from the Federal Aviation Administration who served stateside during the Korean Conflict. Bowen recently moved into the Legend facility following several mini strokes and a diagnosis of short-term memory loss. "It's been pretty hard trying to handle expenses on my own and being able to replace savings," said Marie Bowen, his wife of 57 years. Finding a nearby facility and learning about the special veterans' pension has been a godsend, she said.

VA Disability Evaluation System: The Department of Veterans Affairs' Advisory Committee on Disability Compensation met this week in Washington and heard from the VA's Executive Director of the VA-DoD Collaboration Service, Mr. John Medve, who announced that the Disability Evaluation System (DES) pilot program will be expanded worldwide to replace the existing DoD legacy program over the next twelve months. The pilot program came about as a result of the Walter Reed scandal in 2007 that uncovered wounded and disabled service members were receiving "low-balled" ratings as a result of the DES process. Several commissions that investigated Walter Reed and the DES process recommended eliminating dual VA and DoD disability evaluations, but using one medical exam and having DoD use the VA disability ratings in evaluations by the Services' Physical Evaluation Boards. The pilot, which has proven to improve the speed, effectiveness, and transparency of the DES review process, will expand from the current 27 sites to an additional 28 sites during this year's first phase. The system will be expanded to cover all remaining sites in additional three phases, with a target completion of October 2011.

LTG James Terry Scott (USA-Ret.), Chairman of the VA Advisory Committee, also announced that the committee plans to delve deeper into VA philosophy in assessing individual unemployability and the methodology behind presumptions. Scott made the announcement at the two-day meeting where the committee received progress reports on the VA Schedule of Rating Disability re-write project and VA's roll-out of on-line Disability Benefits Questionnaires. The DoD efforts are being led by Deputy Under Secretary of Defense for Personnel and Readiness John R. Campbell, a Vietnam-era veteran and Purple Heart recipient recently appointed to this position after leading organizational change at several fortune 500 companies. Patriot Guard Riders: As the U.S. Supreme Court contemplates whether protestors at military funerals are protected under First Amendment free-speech rights, a motorcycle group that travels the country attending those funerals as a show of support and respect rides on, undeterred by the political fray. About 200,000 members of the Patriot Guard Riders attend military funerals to honor those who died for or served their country and to support their grieving families. They also escort the bodies of fallen servicemembers as they arrive from Dover Air Force Base, Del., for burial in their hometowns across America. The riders take part in these events only at the family's request and regardless of whether protestors are expected says Bill Richart, national president of the group's board of 11 directors. "What we do is never about the protestors," he said. "We are not a counterprotest group. We don't go anywhere because of them, and we don't not go anywhere because they are not there. ... It's about being there for the families, recognizing their loss and ensuring they know that people care."

Richart emphasized that the riders have no political agenda and take no official position on the pending Supreme Court decision. In that case, Albert Snyder, father of Marine Corps Lance Cpl. Matthew Snyder, who was killed in Iraq in 2006, sued the Westboro Baptist Church of Topeka, Kan., for emotional distress after church members demonstrated and carried offensive signs at his son's funeral in Westminster, Md. A lower court ruled in Snyder's favor. However, the church appealed the decision, arguing to the Supreme Court earlier this month that the protests are protected speech under the First Amendment. As the issue plays out in the courts, the Patriot Guard Riders continue their missions around the country. Richart, an Air Force veteran who deployed to Dharan, Saudi Arabia, during Operation Desert Storm, said he and his fellow riders feel a special connection to the grieving families they support. "If you go out there and you give a couple hours of your time and show families that people care and share their loss, it's very touching to them and to us," he said. National D-Day Memorial: The National D-Day Memorial is a national war memorial located in Bedford, Virginia which serves as the national memorial for US D-Day veterans. It stands in tribute to the valor, fidelity and sacrifice of all Allied Armed Forces during the D-Day Invasion of Normandy, France on 6 JUN 44 during World War II. The memorial, bordering the Blue Ridge Mountains in south-western Virginia, is a large area comprising 88 acres that overlooks the small town of Bedford. It officially opened on 6 JUN 01 with 15,000 people present, one of whom was then President George W. Bush. The memorial sees roughly 85,000 visitors a year. Bedford was selected for the National D-Day memorial because the town suffered the greatest per capita loss of life during the invasion of any town in the country. In addition to the memorial's static displays, on

several weekends throughout the year, the memorial hosts events relating to remembering WWII. Examples of such events have included a weekend long encampment of WWII re-enactors and a WWII style religious mass in addition to Memorial, Independence, Veteran's, and D-Day activities that occur annually. Refer to the memorial's website www.dday.org for event information. 22 The Memorial and the Memorial Store hours are Tuesday through Sunday 1000 to 1700. If you have official business with the Foundation, its operating hours are Monday through Thursday 0900 to 1700 and Friday 0900 to 1330. the Physical Address for the Memorial is 3 Overlord Circle, Bedford, VA 24523 whereas the mailing address is P.O. Box 77, Bedford, VA 24523. During the months of January and February and part of March, the invasion pool is drained for maintenance so a trip should be planned accordingly if you desire to see the full effect of the memorial. It is recommended that you call or email the memorial ahead of time to confirm hours of operation. This can be done at (540) 586-3329/7200 or (800) 351-DDAY or dday@dday.org.

A recent controversy has some historians and most veterans of WWII up in arms. The Memorial revealed a bust of Joseph Stalin to add to the busts that were already present of Winston Churchill and FDR. The Memorial Foundation maintains that Stalin is partly responsible for victories on the Western Front due to his involvement on the Eastern Front and that overall, the war was won with Russia's help. Detractors liken it to memorializing Saddam Hussein because Iraq was an ally to the United States during the 1980's. Critics of the bust point out that Stalin murdered at least 20 million people, and that his troops did not participate at the D-Day landing. On 28 SEP, the .the memorial's board of directors announced that it will take down for now the controversial bust of Soviet dictator Joseph Stalin, along with busts of other Allied world leaders on display at the Bedford site. The statues' departure will last until an unspecified time when they can be placed in a 'more appropriate venue for Allied leader interpretation at the memorial. Commemorative Coin Program: A bill which would require the Secretary of the Treasury to mint and issue coins recognizing the United States Army 5-Star Generals has been signed into law by the President. The program includes \$5 gold coins, \$1 silver coins, and half dollar clad coins to be released during 2013. The bill H.R. 1177: 5-Star Generals Commemorative Coin Act had been introduced on 25 FEB 09 by Rep. Dennis Moore of Kansas. The bill passed the House on 20 MAY and the Senate on 28 SEP 2010. With the President's signature on 8 OCT 2010, the bill became Public Law No: 111-262. There are five U. S. Army 5-Star Generals who will be honored with the upcoming commemorative coin program: George Marshall, Douglas MacArthur, Dwight Eisenhower, Henry Arnold, and Omar Bradley. The authorizing legislation states that the design of the coins shall include portraits of all five of the 5-Star Generals. The designs would be selected by the Secretary of the Treasury following consultation with the Command and General Staff College Foundation, the Commission of Fine Arts, and review by the Citizens Coinage Advisory Committee.

Maximum authorized mintages are also established for not more than 100,000 of the \$5 gold coins, 500,000 of the \$1 silver coins, and 750,000 of the half dollar clad coins. Both proof and uncirculated versions of the coins would be available, with at least one U.S. Mint facility used to strike each version. The release of the coins will also coincide with the celebration of the 132nd anniversary of the Founding of the Army Command and General Staff College. Surcharges added to the cost of each coin would be distributed to the Command and General Staff College Foundation to help finance the College. With the approval of the 5-Star Generals Coins, the schedule for commemorative coin programs has now been filled through 2013. Generally, only two programs may be approved for each year. The current schedule of upcoming programs is:

2011 United States Army & Medal of Honor 2012 United States Army Infantry & Star Spangled Banner 2013 Girl Scouts Centennial & 5-Star Generals 2014 Civil Rights Act of 1964

### Mom's Meat Loaf

## Ingredients:

Extra-lean beef improves the fat and cholesterol levels, but a healthy amount of chopped vegetables (carrots, celery, and onion) and lycopene-rich tomato paste bring bonus nutrients to this family dish.

2 slices bread, crumbled

1/4 cup skim milk

3/4 pound extra-lean ground beef

1 cup grated carrots

1 stalk celery, finely chopped

1 medium onion, minced

2 cloves garlic, minced

1 can (6 ounces) no-salt-added tomato paste

1 egg white, slightly beaten

1/2 teaspoon dried thyme

1/2 teaspoon salt

1/4 teaspoon pepper

#### Preparation:

Preheat oven to 400°F. Line 8-1/2- x 4-1/2-inch loaf pan with foil.

In large bowl, combine bread and milk. Add beef, carrots, celery, onion, garlic, tomato paste, egg white, thyme, salt, and pepper. Mix until well combined.

Transfer to prepared pan and bake 25 minutes, or until cooked through. Serve hot, warm, or chilled.
