


USSVI vests are also available to order thru the SK.

Creamy polenta with roasted red pepper

Polenta, coarse-grind Italian cornmeal, can be served hot and creamy, cut into shapes and grilled, or baked until set. Here, it's mixed with red pepper for added flavor and color.

Ingredients

- 1 red bell pepper, roasted and seeded
- 1 garlic clove
- 1 3/4 cups water
- 1 3/4 cups plain soy milk or 1 percent low-fat milk
- 1 tablespoon extra-virgin olive oil
- 1/2 teaspoon salt
- 1 cup polenta, preferably stone-ground
- 2 tablespoons grated Parmesan cheese
- 1 tablespoon chopped thyme

Directions

In a blender or food processor, combine the roasted pepper, garlic and 1 tablespoon of the water. Process until smooth. Preheat the oven to 450 F. Lightly coat a 9-inch round cake pan with olive oil cooking spray.

In a large saucepan, combine the soy milk, remaining water, olive oil and salt. Whisk in the polenta and place over medium heat. Whisk constantly until the polenta begins to thicken. Reduce the heat to low and resume stirring with a wooden spoon. Cook, stirring frequently, until the polenta pulls away from the sides of the pan, about 15 minutes. Pour the mixture into the prepared cake pan and sprinkle with the cheese. Bake until firm, about 15 minutes. Let stand in the pan for 10 minutes before serving. Cut into 6 wedges and sprinkle with the thyme.

Vet Toxic Exposure~Lejeune Update 32: Thousands of newly released documents about water contamination at Camp Lejeune add to the evidence that the military long knew about tainted tap water blamed for deaths and illnesses of Marines and their families, and that officials covered up the information for years, a North Carolina congressman said Friday. "For the last 30 years, instead of saying there could be health effects and or even we don't know what the health effects are, they've minimized it," said Democratic Rep. Brad Miller. On 19 JUL, Senate Judiciary Committee Chairman Patrick Leahy (D-VT) released more than 8,500 Department of Defense documents relating to the water contamination that continued at the base for decades. The release came the same week the Senate approved a bill to provide health care for Marines and their relatives who suffered due to the contamination. The bill covers Marines who lived or worked at the base from Jan. 1, 1957, to Dec. 31, 1987. Water

supplied to Camp Le-

jeune's main family housing areas was contaminated by dry cleaning solvents and other sources from the 1950s until 1987. Health officials believe as many as 1 million people may have been exposed to tainted water. Among them was Janey Ensminger, who was 9 when she died of leukemia in 1985. The bill providing health care for the victims is named after her. Since her death, her father has pushed to find information about the contamination. Jerry Ensminger, a retired Marine who lives in Elizabethtown, N.C., has started combing through the documents and said he has already found one from 1985 that describes trichloroethylene — or TCE — as toxic. The U.S. Environmental Protection Agency didn't classify TCE as a known cause of cancer in humans until September. The Marines have said for years they didn't know at the time that TCE was harmful because it wasn't included in the federal Safe Drinking Water Act. Ensminger said. "Yet they had it classified as toxic in their own documents and they're still

lying about it," he said. He added, "The facts are, they have all these documents, and they knowingly poisoned their own people." [Source: AP article 21 Jul 2012 ++]

Military Funeral **Disorderly Conduct Update 21:** In the omnibus veterans affairs bill passed by the Senate 18 JUL are additional restrictions on protests near military funerals and tougher penalties on groups that violate the law. Sen. Olympia Snowe (R-ME) sponsored the original "Sanctity of Eternal Rest for Veterans" or SERVE Act (S.815) following a U.S. Supreme Court ruling in a case centered on an anti-gay church group that was protesting at military funerals around the country. The Supreme Court ruled in March 2011 that the Westboro Baptist Church's protests were protected free speech. But Snowe and other lawmakers wanted to place additional restrictions on when, where and how groups could protest near funerals for military personnel. Members of the Kansasbased church protested at a funeral in Maine for

a soldier killed in Iraq. A student at Searsport High School, Zach Parker, campaigned for a ban on protests at military funerals. Snowe's SERVE Act was incorporated into the veterans bill passed by the Senate on Wednesday night. The act would: double the "quiet time" before and after military funeral services to 120 minutes; increase the buffer zone around the funeral service from 300 to 500 feet and around the access point to funerals from 150 to 300 feet; and impose stiffer penalties on violators."Our nation has a vested interest in honoring those who serve in our armed forces and this bill achieves that while respecting the intent of the First Amendment to our Constitution," Snowe said in a statement. Gift Card Scam:

Cell phone users nationwide are receiving suspicious text messages that claim to be from Target. The texts tell consumers they won a drawing for free gift card... and all they have to do is click a link and enter their address and phone number. Unfortunately, the gift card drawing is fake. And the texts are just a way to collect personal info for shady advertisers. The text messages vary, but all contain an offer of a gift card, a URL to visit and PIN to enter on the website. A typical text would read: "Your entry in our drawing WON you a free \$1000 Target giftcard! Enter "917" at http:// www.target.com.tgrz.biz to claim it and we can ship it to you immediately" The text's URL leads to a website that is branded with Target's colors and its mascot dog Bullseye. You are asked to enter the PIN and an email address. Then, you are taken to a form and instructed to fill out your name, cell number and mailing address. One recipient reported completing the form and receiving a second PIN in return. The confirmation message instructed her to wait for a follow-up text and enter that new PIN at the website address she received. The text turned out to be promoting a horoscope website, and no mention was made of the Target gift card. Refer to the BBB

BRAC Update 27: Another round of military base closings and realignments is on tap in 2014 or 2015 -- the sixth since the Pentagon began axing installations built during the Cold War. More than 130 major facilities were shuttered in the first five rounds, the last of which occurred in 2005. The next round will likely slash several dozen facilities around the country. The Pentagon says more closings are necessary to cut excess capacity and save money. But bases are an important piece of local economies. providing many direct and indirect jobs. The prospect of more base closings unnerves members of Congress, who are often cheerleaders for home-state military bases and the federal money that comes with them. They're not eager to appoint a base closing commission just yet, but in a year or so, pressure from

the Pentagon will force them to do so. Base closings have a mixed impact on communities. Some facilities are successfully converted to thriving civilian uses. In Alameda, Calif., for example, where aircraft were once overhauled at the Alameda Naval Air Station, Hollywood movie studios are shooting films and start-up companies are working to bring electric cars and other new technologies to market. Other closed bases are not so successful. After consulting with sources on Capitol Hill and elsewhere, The Kiplinger Letter identified bases that are sure to be eved for closing or realignments once the base commission gets rolling. They are:

USS Miami (SSN-775):

Navy investigators have determined that a civilian laborer set a fire that caused \$400 million in damage to a nuclearpowered submarine because he had anxiety and wanted to get out of work early. Casey James Fury of Portsmouth, N.H., faces up to life in prison if convicted of two counts of arson in the fire aboard the USS Miami attack submarine while it was in dry dock May 23 and a second blaze outside the sub on June 16. The 24-year-old was taking medications for anxiety and depression and told investigators he set the fires so he could get out of work, according a seven-page affidavit filed 23 JUL in U.S. District Court in Portland. Fury made his first court appearance that afternoon but did not enter a plea. Magistrate Judge John Rich III scheduled a combined detention and probable cause hearing for next month. The U.S. attornev's office has filed a motion asking that he be held without bail. Fury's federal public defender. David Beneman, did not speak in court and earlier in the day declined to comment to The Associated Press. People who appeared to be family members attended the hearing but also declined to comment.

The Miami was in dry dock at Portsmouth Naval Shipyard in Kittery, Maine, for an overhaul when the fire damaged the torpedo room and command area inside the forward compartment. It took more than 12 hours to extinguish during which six fire crew members were injured while trying to quell the blaze. A second fire was reported June 16 on the dry dock cradle on which the Miami rests,

but there was no damage and no injuries. Fury, who was working on the sub as a painter and sandblaster, initially denied starting the fires but eventually acknowledged his involvement, the affidavit states. He admitted setting the May 23 fire, which caused an estimated \$400 million in damage, while taking a lie-detector test and being told by the examiner he wasn't being truthful. Fury told Timothy Bailey, an agent for the Naval Criminal Investigative Service, that "his anxiety started getting really bad," so he grabbed his cigarettes and a lighter, walked up to a bunk room and set fire to some rags on the top bunk. The Navy originally said the fire started when an industrial vacuum cleaner sucked up a heat source that ignited debris inside. Fury said he set the second fire after getting anxious over a textmessage exchange with an ex-girlfriend about a man she had started seeing, according to the affidavit. He wanted to leave work early, so he took some alcohol wipes and set them on fire outside the submarine He said he initially lied about setting the fires



"because he was scared and because everything was blurry to him and his memory was impacted due to his anxiety and the medication he was taking at the time". Fury told NCIS agent Jeremy Gauthier that he was taking three medications for anxiety, depression and sleep, and a fourth for allergies. He checked himself into an in-patient mental health facility on June 21 and checked himself out two days later. If convicted of either charge, in addition to life imprisonment he could face he could receive a fine of up to \$250,000 and be ordered to pay restitution, officials said.

USS Miami (SSN-755) is a United States Navy attack submarine of the Los Angeles class. She is the third vessel of the U.S. Navy to be named after Miami, Florida. The contract to build her was awarded to the Electric Boat division of General Dynamics Corporation in Groton, Connecticut, on 28 November 1983 and her keel was laid down on 24 October 1986. She was launched on 12 November 1988 sponsored by Mrs. Jane P. Wilkinson, and commissioned on 30 June 1990 with Commander Thomas W.

Obit ~ Ernest **Borgnine:** U.S. Navy Veteran and longtime movie icon Ernest Borgnine died at the age of 95 on July 8. Raised during the Great Depression, Borgnine enlisted in the Navy in 1935, mainly to help his family through the difficult times. He was discharged in 1941, but quickly re-enlisted after the attack on Pearl Harbor. During his 10 year naval career reaching the rank of gunner's mate 1st class, he served on the U.S.S. Lamberton and on the U.S.S. Sylph from 1941 until his discharge in 1945. . His military decorations included the Navy Good Conduct Medal, American Defense Service Medal with Fleet Clasp, American Campaign Medal, Asiatic-Pacific Campaign Medal, and the World War II Victory Medal . Also, Borgnine

received the honorary rating of chief petty officer in October 2004, from Master Chief Petty Officer of the Navy Terry D. Scott for Borgnine's support of the Navy and naval families worldwide. After the war, he used his G.I. Bill to attend the Randall School of Drama in Hartford, Conn. In 1949, his acting career was launched on Broadway and led to roles in feature films such as "The Dirty Dozen," and "The Poseidon Adventure." While Borgnine was best known for his role as Cmdr. Ouinton McHale in the popular television show, "McHale's Navy," he was also an avid supporter of Veterans. In 1987, he was co-chair, along with Army Nurse Corps Veteran and fellow actress Martha Ray, for VA's National Salute to Hospitalized Veterans. Working with VA's Voluntary Service staff, Borgnine and Ray visited Veterans at numerous VA facilities, uplifting the spirits of all Veterans that they met. He also served in various capacities at many Veterans' events and celebrations

Lost Boats— USS Pompano SS 181

USS *Pompano* (SS-181), a United States *Porpoise* -class submarine was the second ship of the United States Navy to be named for the pompano.

Her keel was laid down on 14 January 1936 by the Mare Island Navy Yard in California. She was launched on 11 March 1937, sponsored by Mrs. Isaac I. Yates, and commissioned on 12 June 1937, Lieutenant Commander Lewis S. Parks in command.

Engine problems: Six boats were built in this group, with three different diesel engine designs from different makers. Pompano was fitted with H.O.R. (Hooven-Owens-Rentschler) 8-cylinder double-acting engines that were a license-built version of the MAN auxiliary engines of the cruiser Leipzig. Owing to the limited space available within the submarines, either opposedpiston or, in this case, double-acting engines were favored for being more compact. Pompano's engines were a complete failure and were wrecked during trials before even leaving the Mare Island Navy Yard. Pompano was laid up for eight

months until 1938 while the engines were replaced. Even then the engines were regarded as unsatisfactory and were replaced by Fairbanks-Morse opposed piston engines in 1942.

Pompano's engines were a unique prototype of the H.O.R. engine, having 8 cylinders. An inherent problem with doubleacting cylinders, owing to the piston rod reducing the piston area on one side, is an imbalance in the force on each side of the piston. The H.O.R. engines were plagued by vibration, and other, problems as a result. While Pompano was still being built, the Salmon class submarines were ordered. Three of these were built by Electric Boat, with a 9cylinder development of the same H.O.R. engine. The 9-cylinder arrangement was an attempt to re-balance the engine, so reducing the overall effect of vibration across the engine. Although not as great a failure as *Pompano*'s engines, this version was still troublesome and the boats were later re-engined with the same General Motors16-248 two-stroke V16 Diesel engines as their sister boats. Other Electric

Boat constructed submarines of the *Sargo* and *Seadragon* classes were also built with these 9-cylinder H.O.R. engines, but later re-engined.

Service history: In the years preceding World War II, *Pompano* operated out of Mare Island off the West Coast of the United States, training her crew and patrolling in a constant state of readiness.

Although the submarine was awarded a battle star for the attack on Pearl Harbor, she had not yet arrived from Mare Island. Reaching port shortly after the attack, she sailed from Pearl Harbor on 18 December 1941 for her first war patrol, devoted mainly to reconnoitering the eastern Marshall Islands for an aircraft carrier strike in January. Aircraft from Enterprise bombed her in error on 20 December, but she escaped damage.

Pompano arrived off
Wake Island on 1 January 1942 to gather intelligence, approaching close enough to see
Japanese machine gun posts. On 8 January, "be-devilled by breakdowns in her temperamental H.O.R. engines" she inspected Bikar and subsequently viewed several other islands of the

group.

She sighted several large ships protected by patrol craft in the harbor at Wotje. On 12 January, one of these stood out: Yawata, with four escorts. Pompano fired four Mark 14 torpedoes for two hits, and the target apparently broke up, disappearing from view. Five days later, when one of the patrol boats steamed out of the harbor, Pompano worked her way between him and the channel. Both torpedoes exploded prematurely (a constant problem for the Mark VI exploder), foiling her first attack. Then, with the enemy charging directly for her, the submarine waited until her target was 1,000 yards away before firing two more torpedoes "down the throat". They missed, and the enemy delivered an ineffective depth charging.

After thoroughly reconnoitering Maloelap, *Pompano* departed on 24 January, arriving at Pearl Harbor on 31 January. On the same day, aided by her reports, the fast carriers of the Pacific Fleet struck the Marshall Islands.

On her next patrol, to Japanese home waters,

Pompano left Pearl Harbor on 20 April 1942 (with a load of older Mark 10 torpedoes, due to production shortages at Newport Torpedo Station), refueled at Midway Island, and entered her area 7 May patrolling the sea lanes west of Okinawa and in the East China Sea. Shipping was scarce, but on 24 May, she caught a large sampan and sent it down with gunfire. On the next day, after chasing for seven hours and fighting a motor fire in the process, she torpedoed Tokyo Maru, which exploded and sank.

As *Pompano* shifted her patrol area to the main route between Japan and the East Indies, a large transport escorted by one destroyer caught her eye on 30 May. Running to a position ahead of the convoy, she waited until her victim was only 750 yd away, scoring solid hits (with two more Mark 10 torpedoes) which sank *Atsuta Maru* two and a half hours later.

With her fuel getting low and a strong possibility of not being able to refuel at Midway Island on the way back because of the Japanese attempt to invade the island, *Pompano* began to work eastward. On the morning of 3 June, she found a small inter-island steamer, setting the vessel afire with gunfire.

On 5 June, while on the shipping route between Japan and the Mariana Islands, the submarine caught a trawler and sank it with gunfire. Two days later, word arrived the Japanese fleet, decisively defeated in the Battle of Midway, was fleeing toward Japan. *Pompano* took up a position to intercept them, but made no contact. On 13 June 1942, she put into Midway for refueling. and on 18 June arrived in Pearl Harbor. She was credited with sinking five ships for a total of 16,500 tons; postwar, only two for 8,900 tons were confirmed.

After a refit - and a change of command, to Willis M. Thomas - she sailed from Pearl Harbor again on 19 July, bound for Japan, on her third war patrol. By 3 August, she was in her area, and began patrolling within four miles of the coast. A few minutes past midnight on the morning of 7 August, she launched four torpedoes at a large freighter, but all missed.

Two days later, a destroyer sighted *Pompano*, and opened fire. As *Pompano* ducked under, shells could be heard hitting the water. Soon a heavy barrage of depth charges exploded close aboard. Rising water in the engine room necessitated starting the pumps, which brought another

heavy barrage. After running aground twice while attempting to escape, wiping off the sonar heads and with her battery almost exhausted, she surfaced, determined to fight on, only 1,000 yd from shore, evaded the ashcan and hastily cleared the area

Undaunted, at noon on 12 August 1942, she dove and set up on a freighter, which was coming into position when *Pompano* sighted an enemy destroyer coming down between the sub and her target. Firing two torpedoes, *Pompano*'s men heard two very loud explo-

sions, and saw a huge column of spray and water through the periscope, blotting out the destroyer's bow at 700 yd. Both sets of screws stopped immediately. As *Pompano* closed the freighter, it settled below, evidently a victim of the second torpedo.

Another attack on 21 August failed when a convoy escort kept Pompano down while three freighters passed. On the morning of 23 August, she launched another torpedo attack on a large passenger freighter, only to have all three torpedoes miss. The target replied with his deck gun. Surfacing after nightfall, the sub sighted a destroyer 7,000 vd away but could not attack when the destrover sighted her in turn, and launched depth charges close aboard.

The last attack of the patrol came while *en route* Midway when, on the 500-mile circle from Tokyo, *Pompano* sighted *Naval Auxiliary 163* lying to. Since the vessel was of shallow draft, and since there were no other enemy forces visible, the submarine surfaced and engaged with deck guns, sinking the enemy an

hour later. *Pompano* sighted an unidentified periscope the next morning, but it disappeared before she could attack. The ship arrived Midway on 8 September and Pearl Harbor four days later.

An overhaul at Mare Island Navy Yard, including the installation of new main engines, kept the ship in the yard until 18 December 1942. Sailing back to Pearl Harbor, she departed on her fourth war patrol on 16 January 1943. The Marshalls were her first objective, and at dawn on 25 January, she was off Kwajalein. After reconnoitering the area, she moved on to Truk to begin patrolling.

Catching a tanker with only one escort on 30 January, she damaged it with torpedoes. Another tanker came in view on 4 February, but only one of the stern torpedoes hit; damaged, it managed to make port. Moving back to the Marshalls, Pompano sighted another tanker on the morning of 18 February. Two hits slowed the Japanese down, but depth charging held Pompano down until her target had escaped. After reconnoitering Rongerik, Rongelap, and Bikini Atoll, she returned home, mooring at Midway on 28 February. She would get credit for no sinkings this time out.

She left Midway again on 19 March, bound for Tokyo. During the entire patrol, with 26 days on station, she sighted only four torpedo targets, one of them a submariner's dream an aircraft carrier, identified as Shokaku. Pompano fired six torpedoes at long range 4,000 yd, and was credited with damage for 28,900 tons. She made only one other attack, spent two-thirds of the patrol fighting rough weather, and returned to Midway on 5 May, then to Pearl Harbor five days later.

On 6 June, the submarine was underway again from Pearl Harbor for the Nagoya, Japan. Stopping briefly at Midway to top up supplies, she entered her area on 19 June, patrolling across traffic lanes from Japan to the south. She celebrated the Fourth of July by putting two more torpedoes into a grounded ship, damaged by an earlier attack by

Harder. Next day, she encountered a convoy, firing four torpedoes with no hits. On 7 July, she came upon two destroyers and, showing surprising aggressiveness, launched three torpedoes at each, missing every time. Two days after that, an ill-advised long shot at a three-ship convoy also missed, while on 10 July, a tanker escaped thanks to two erratic Mark 14s. Her last two torpedoes were extreme-range misses against a freighter. A good -sized sampan was sunk with gunfire on 17 July. Pompano ended the unsuccessful patrol at Midway on 28 July.

Pompano left Midway on 20 August, bound for Hokkaidō and Honshū. She was never heard from again, and when she failed to return, was presumed

lost. The Japanese knew she was in her area, however, for two ships fell to her torpedoes during September, Akama Maru on 3 September, and Taiko Maru on 25 September. The enemy made no antisubmarine attacks during this period in *Pompano*'s area, so newly-laid mines in the vicinity, not known to U.S. Navy intelligence until after she sailed. probably sank her. Pompano was stricken from the Naval Vessel Register on 12 January 1944.

Awards: *Pompano* received seven battle stars for service in World War II.
