Little Known Submarine Facts—Ron Martini/David Barth

At the end of WWII, Japanese submarine I-14 was given to Commander John S.
"Junior" McCain, son of the carrier task force commander, Vice Admiral John S.
"Slew" McCain (and father of Arizona Senator John S.
McCain, III).

The George Washington sail on display at the Submarine Force Museum and Library

outside the main gate at Subase/Groton is NOT 100 percent 598! Some of it is from the Abraham Lincoln sail. The 598 hit a Japanese ship and parts of the 602 was used in the repair.

There was a Torpedo Factory in Washington DC in WWII. It is now an art museum of the same name in Alexandria, VA and draws some 500,000 visitors each year.

The U.S. sold 74 Diesel submarines to 13 foreign countries. Turkey and Brazil bought 26 and 11 respetively.

Little known was that Japan "borrowed" the Mingo which was eventually returned and sunk as a target.

The initial Scorpion was cut apart to build the George Washington. This was the only boat cut to build a boomer. However parts from other Skipjack Class boats went into the Patrick Henry and even some parts meant for the Shark were diverted to the Robert E. Lee.

A nuclear powered guided missile launching submarine

(SSGN), was similar in concept to the Halibut, a diesel-powered submarine, but with the S5W nuclear reactor power plant. SSGN 600 was to be one of these SSGNs. Budgeted for in 1959, it was to have four hangers, each carrying one or more modified, liquidfueled Jupiter missiles in a configuration which had four missile tubes in an enlarged sail. This plan was ended in 1956 when the Jupiterequipped submarine program was scrapped and work turned to designing a solid-fueled missile that was to become the Polaris.

I obviously was never a Navy Captain but go by "Capt. Frank" for three reasons. I was a Reserve Captain in the Monroe County (Florida) Sheriff's Department for 12 years. I am also a licensed Merchant Marine Captain (100 Tons) and after the Navy I flew as a Boeing-737 Captain until about two years ago when again due to Kidnev Stones I was forced to retire.

It is starting to warm up a bit and I am hoping that we can organize a meeting/ride very soon. I realize that we are spread out over two states but we will just do the best we can. I am open to suggestions as to where we should hold a meeting that can accommodate the most members.

I would like to throw this out for discussion & have already run it past national. Since the requirement to form a chapter has been reduced it might be a good time to divide the Carolinas Chapter in two, forming the North & South Carolina chapters. Then to leave it optional as to which one each member would like to be a member of. It seems to me that the NC Chapter works best in my area, mostly Western NC and the Northwestern part of SC. Our Base Holland Club Member of the Month is Robert "Bob" Boyd RMCS(SS) (Ret). Bob lives with his wife Patricia in Spring Hill, Florida but is looking forward to moving back to North Carolina. Bob was born in Greensboro and moved to the Wrightsville Beach area when he was about four years old. The family then moved to Candor. NC. Bob said that he had a brother that was in the Navy and had decided at an early age of 16 that he was going to join the Navy and "do twenty". He did just that right out of high school, in 1954. Bob was in the last part of RM school when him and a buddy decided they both would try out for Submarine Duty. Bob's buddy didn't make it, but Bob got orders to Sub School in New London, CT.

Bob first boat was the USS Redfin SSR-272. Bob says this was probably his favorite duty in his entire Navy career

due to the fact he got to serve with about twenty or so WWII submariners. He learned from the best. But he told me he still gets calls from some of the sailors he taught on the boomers he served so he must have pasted some knowledge along. Seems we all do.

Bob was a "Hot Runner" and qualified fast on the Redfin. Bob also served on the USS Sennet SS-408, USS John Marshall SSBN611G

(Commissioning Crew), USS Lewis and Clark SSBN644 (first 11 crew members), and while serving with COMSUB-FLOT7, did some time on the USS Salmon SS573. Bob made RMC in under 8 years and RMCS at first pass.

They promised Bob E-9 to re-enlist, but he had just been married and had two small children and wanted to move his wife and kids from Japan back to either Florida or North Carolina. So he turned in his papers and headed to Florida with his family.

Bob knowing that the electronics field was flooded with people, sought work in another field. One in which he had no training or background. He walked into a bank and talked to a bank

vice-president about a job. The VP asked what he wanted to make. Bob replied "What do you make?" Bob was hired! Bob worked in the banking industry for 36 years from teller to Vice President, and every job in between. 

Vegetarian Korma

This is an easy and exotic Indian dish. It's rich, creamy, mildly spiced, and extremely flavorful. Serve with naan and rice.

Ingredients:

1 1/2 tablespoons vegetable oil
1 small onion, diced
1 teaspoon minced fresh ginger root
4 cloves garlic, minced

2 potatoes, cubed 4 carrots, cubed

1 fresh jalapeno pepper, seeded and sliced 3 tablespoons ground unsalted cashews

1 (4 ounce) can tomato sauce 2 teaspoons salt

1 1/2 tablespoons curry powder 1 cup frozen green peas

1/2 green bell pepper, chopped 1/2 red bell pepper, chopped

1 cup heavy cream 1 bunch fresh cilantro for garnish

Directions:

Heat the oil in a skillet over medium heat. Stir in the onion, and cook until tender. Mix in ginger and garlic, and continue cooking 1 minute. Mix potatoes, carrots, jalapeno, cashews, and tomato sauce. Season with salt and curry powder. Cook and stir 10 minutes, or until potatoes are tender.

Stir peas, green bell pepper, red bell pepper, and cream into the skillet. Reduce heat to low, cover, and simmer 10 minutes. Garnish with cilantro to serve.

Medicare Reimbursement Rates 2014: Could this be the year

that the "doc fix" is finally fixed? It will be if Reps. Allyson Schwartz (D-PA) and Joe Heck, (R-NV) have their way. They introduced the Medicare Physician Payment Innovation Act that would ensure patient access to physicians while promoting efficiency, quality and value in health care delivery. The bipartisan legislation would permanently repeal the flawed Sustainable Growth Rate (SGR) formula and defines a clear path toward comprehensive reforms of Medicare payment and delivery systems. For years, the SGR formula which is used to determine payments for physicians' services under Medicare and TRI-CARE, has threatened to impose steep cuts in Medicare payments for physicians who provide care to seniors and military beneficiaries. The cuts drive physicians out of Medicare, creating severe access problems for senior citizens and members of the military community. The fiscal cliff legislation passed by Congress at the end of the year contained a one-year payment patch for physicians who treat Medicare/TRICARE pa-

tients. The legislation would implement delivery system and payment reforms that would ensure long-term stability in the Medicare physician payment system and would contain the rising growth in health care costs. The Medicare Physician Payment Innovation Act:

Permanently repeals the SGR formula;

Provides annual positive payment updates for all physicians for four years;

Ensures access to preventive care, care coordination, and primary care services through increased payment updates for those services;

Aggressively tests and evaluates new payment and delivery models;

Identifies a variety of unique payment models to provide options for providers across medical specialties, practice types, and geographic regions;

Stabilizes payment rates for providers who demonstrate a commitment to quality and efficiency within a fee-for-service model; and,

Ensures long-term stability in the Medicare physician payment system

through predictable updates that accurately reflect the cost and value of providing health care services in coordinated care models.

Independent Budget FY 2014: The White House may be late in preparing its 2014 budget request, but a powerful collection of veterans groups unveiled their own plan 5 FEB for a \$4.8 billion increase in veterans health care, benefits administration, construction and medical research funds. Prepared by four groups — Veterans of Foreign Wars, Disabled American Veterans, Paralyzed Veterans of America and Am-Vets — the so-called Independent Budget is endorsed by 45 military, veterans and charitable organizations and will be used as a benchmark to decide if the Obama administration's Veterans Affairs Department budget request for 2014 is adequate. This is the 27th such budget sent to the White House and Congress.

Veterans are asking for a \$3.3 billion increase for health care over the 2013 budget, \$1.2 billion more than the Obama administration estimated would be needed for medical programs. In their report detailing the request, the groups say there are several reasons for what amounts to a 6 percent increase: They expect an influx of new veterans, some severely disabled and some needing care as a result of reductions in the activeduty military, and they also anticipate more veterans may turn to VA as the cost of private-sector health care spirals, the report says. The budget also asks for a 4.8 percent increase for medical and prosthetic research, a 10.4 percent increase in benefits administration aimed at speeding the processing and accuracy of benefits claims, and a whopping 77 percent increase in construction funds to pay for what the report says are desperately needed and overdue projects. In a statement, VFW National Commander John Hamilton said VA has been getting "less than half" of what it needs to modernize

facilities. "Just as disabled veterans require more medical assistance as they age, so do VA medical facilities that average more than 60 years old. "Though we have yet to see what the administration is proposing for fiscal year 2014, we fear the weak economy will again influence what the administration requests for major and minor construction," he said.

The report urges continued attention to helping new veterans find jobs. "With more than 800,000 unemployed veterans, and nearly 12 percent of recent veterans searching for work, now is the time for this administration and Congress to stand up for our heroes and ensure they are able to provide for themselves and their families." said AMVETS National Commander Cleve Geer. Employment programs have been mentioned as a legislative priority by the chairmen of the House and Senate veterans' affairs committees and are expected to be discussed at hearings in February and March when military and veterPage 14 Piedmont Periscope

ans groups are invited to testify before the two panels. Another issue that won't go away is the backlog of benefits claims. The report says VA has spent enough time looking at ways to improve the process and should be pushed to implement transformative technology and policies before the end of the calendar year. More staff to process claims might help, the report says, but the groups do not recommend any specific increase. DAV National Commander Larry Polzin said he is encouraged by VA's claims efforts. "We look forward to continued progress in improved accuracy and timeliness," he said, "but uncertainty about funding for VA could have far-reaching consequences for our nation's injured and ill veterans and their families." Tricare Pharmacy Copay Update 10: Tricare pharmacy co-pay increases became effective1 February. The FY 2013 National Defense

| 6 Feb 2013 ++]

Bill required Tricare to increase copayments on brand name and nonformulary medications that are not filled at military treatment centers. There is no increase on generic medications and many co-pays vary based on class of drug and where the prescriptions are filled. For example, the co-pay for generic medications remains \$5 when filled at a network pharmacy and a 30-day supply of brand name medication filled at a retail pharmacy goes from \$12 to \$17. Beneficiaries using Tricare Home delivery will pay \$13 for brand name drugs, however home delivery is for a 90-day supply. The greatest change in co-pays applies to non-formulary medications- a \$25 dollar co-pay increases to \$44 at retail pharmacies and is \$43 through the home delivery system. Prostate Enlargement:

It is common for the prostate gland to become enlarged as a man ages. Doctors call this condition benign prostatic hyperplasia (BPH), or benign prostatic hypertrophy. As a man matures, the prostate goes through two main periods of growth. The first occurs early in puberty, when the prostate doubles in size. At around age 25, the gland begins to grow again. As the prostate enlarges, the layer of tissue surrounding it stops it from expanding, causing the gland to press against the urethra like a clamp on a garden hose. The bladder wall becomes thicker and irritable. The bladder begins to contract even when it contains small amounts of urine, causing more frequent urination. Eventually, the bladder weakens and loses the ability to empty itself, so some of the urine remains in the bladder. The narrowing of the urethra and partial emptying of the bladder cause many of the problems associated

rarely causes symptoms before age 40, but more than half of men in their sixties and as many as 90 percent in their seventies and eighties have some symptoms of BPH. Treatment involves surgery or drugs that block testosterone, a hormone that drives unwanted growth. Side effects can include loss of libido and erectile dysfunction Andrew Schally of the Miami Veterans Affairs Medical Center in Florida and colleagues have developed a new drug, RC-3940-II, which works by blocking gastrin-releasing peptide – another potent growth factor. In rats, a sixweek treatment shrank prostates by 18 per cent. It also shrank human prostate cells by 21 per cent. Importantly, fewer side effects are likely as testosterone pathways are avoided. Lost Boats— USS Perch SS-176



.USS *Perch* (SS-176) - the lead ship of *Perch*-class submarines of the United States Navy, the first Navy ship to be named for the perch.

Her keel was laid down on 25 February 1935 by the Electric Boat Company, in Groton, Connecticut. She was launched on 9 May 1936 (sponsored by Mrs. Thomas Withers), and commissioned on 19 November 1936. Lieutenant Commander George C. Crawford in command. Inter-War Period - After shakedown in the North Atlantic, Perch became a member of the Pacific Fleet when she joined Submarine Squadron 6 (SubRon 6) in November 1937. The following spring she was engaged in the annual fleet problem and did some work on a survey of the Aleutian Islands, entering the Bering Sea on 28 February. In the spring of 1939, Perch operated with the fleet on its cruise to the East Coast.

In October 1939, Perch departed San Diego, California, for Manila where she


became a division flagship and made a summer cruise in 1940 to Tsingtao and Shanghai. She spent the year preceding the war in operations around the Philippines. A week before Japan's attack on Pearl Harbor, Perch rendezvoused with two transports off Shanghai and escorted the Fourth Marines from China to the Philippines. World War II - At the outbreak of hostilities, Perch - commanded by David A. Hurt - was in Cavite Navy Yard. She took part in the rush to clear the Navy Yard on 10 December and watched, at close range, the destruction of Cavite by bombers. That night, Perch slipped through the Corregidor minefields and scouted between Luzon and Formosa (Taiwan) in search of targets. Failing to detect any, she shifted to an area off Hong Kong, and on Christmas night, launched four torpedoes at a large merchantman, all missing. A few days later, she torpedoed a merchantman. Enemy escorts prevented Perch from observing the kill. Perch sailed south to Darwin, Australia, to repair damage, making

several unsuccessful at-

tacks en route. She next made a patrol to Kendari, Celebes (Sulawesi), where she scouted the harbor and made several attempts to get through the narrow entrance to an attack position. After a week of close contact with the enemy, obtaining information, Perch headed south searching for targets. In a night attack on a large merchantman off the eastern coast of Celebes. Perch was hit in the superstructure, forward of the pressure hull of the conning tower, by a high explosive round which blew away the bridge deck, punctured the antenna trunk and temporarily put her radio out of commission. Her crew, by very courageous effort, made repairs on deck at night in waters heavily patrolled by the enemy, and Perch headed for the Java Sea.

On the evening of 1 March 1942. Perch surfaced 30 miles northwest of Surabaya, Java, and started in for an attack on an enemy convoy landing troops to the west of Surabaya. Two enemy destroyers (Amatsukaze and Hatsukaze) attacked and drove her down with a string of depth charges which caused her to bottom at 135 feet. Several more depth charge attacks caused extensive damage, putting the starboard motors out of commission and causing extensive flooding throughout the boat. After repairs, Perch sur-





faced at two o'clock in the morning, only to be again driven down by destroyers. The loss of oil, and air from damaged ballast tanks, convinced the enemy that Perch was breaking up and they went on to look for other kills, allowing her to escape.

With decks awash and only one engine in commission, the crew made all possible repairs. During the early morning of 3 March, a test dive was made with almost fatal results. Expert handling and good luck enabled her to surface, and she began making repairs. Then, as if this was not enough, two Japanese cruisers and three destroyers hove into view and began firing. As shells straddled the boat, her skipper ordered, "Abandon ship, scuttle the boat." With all hull openings open, Perch made her last dive. She was stricken from the Naval Vessel Register

24 June 1942.
The entire crew was captured by a Japanese destroyer. Of the fifty-four men and five officers, all but six — who died of malnutrition in Japanese prisoner-of-war camps — were able to return to the United States after V -J Day.

On 23 November 2006, Thanksgiving Day, the wreck of Perch was located by accident by an international team of divers off the coast of Java. The expedition had hoped to photograph the wreck of Exeter. sunk in the same area on 1 March 1942. Awards- Perch received one battle star for World War II service. The Perch is the subject of an episode of the syndicated television anthology series, The Silent

USSVI Constitution and Bylaws

Here a little more of the USSVI Constitution and Bylaws. As I stated in January we'll do a little each month and the Constitution will be here on the left side and the Bylaws on the right side. The Constitution Article VII is rather long and rather than split it, I'll continue it on Page 19. Now Section 5 on Associate Members was new last September, so read it over. — Moe(SS)

Constitution (continued from February issue)

ARTICLE VI -- FISCAL YEAR

The fiscal year of the organization shall commence on the first day of January and end on the thirty -first day of December in each year.

ARTICLE VII – MEMBERSHIP Section 1. GEN- ERAL

- A. Members who have been discharged from the Armed Forces of the United States of America must have been discharged under honorable conditions. Proof of qualification and honorable service may be required to be provided to assigned base Secretary or Nat'l Membership Chairman.
- B. All members shall be bound by the Organization's Constitution and Bylaws.
- C. A member may choose the Local Base he desires, however, if no choice is made he may be referred to the Base nearest his home or an internet base at the direction of the National Membership chairman.
- D. A member is considered "in good standing" if National dues has been paid for the current year. (C3/04) E. Dues are due and payable effective the last day of December each year. Beginning on Jan 1st a non-renewed member is considered in arrears. Members shall have through 31 January to bring their status up to date. After the above listed dates, members who have not become current in status will be dropped from the rolls of the organization.
- F. Members may join any number of Bases. One Base shall be selected as their (main) primary Base, and all others as (secondary) dual Base(s). Members may only vote from their primary Base in the National elections of the organization.
- G. To avoid conflicts of interest, a Member may only serve as Base Commander for one Base at a time.

Bylaws (continued from February issue)

Since I went long on the Constitution this month, I'll just cover the first of the National Officers from the National Bylaws:

ARTICLE V -- DUTIES OF OFFICERS Section 1. NATIONAL COMMANDER:

The duties of the National Commander shall include, but not be limited to:

- a. Act as the Chief Executive Officer and the Chairman of the Board of Directors.
- b. Cause to be called all regular and special meetings of the organization.
- c. Preside over all regular and special meetings of the organization.
- d. Enforce the Constitution and Bylaws.
- e. Direct and supervise the operation of the organization.
- f. Prepare and present the Board of Directors Annual Report at the Annual Business Meeting.
- h. Submit, in writing, to the Board of Directors for confirmation, all appointed officers and committee chairmanships except as noted in specific committees where the Chairman is listed by the position he fills in USSVI.
- i. Sign all certificates notes, drafts, or bills of exchange, warrants or other orders for the payment of moneys duly drawn by the National Treasurer, except as provided elsewhere in the Constitution and Bylaws, subject to the approval of the Board of Directors.
- j. Be responsible for the promulgation of all pertinent information to the membership of the organization.
- k. Work up, keep current, and pass on immediately to his relief a "Turn Over" folder, including all official correspondence, records, and official materials assigned to his care.
- l. Be an ex-officio member of all committees, except the "Nominations Committee".

More next month, starting with the duties of the Senior Vice Commander. Remember you can always find he entire National USSVI Bylaws at USSVI.org. Happy reading.

USSVI Constitution (ArticleVII con't)

Section 2. REGULAR MEMBERS.

A. Regular membership is restricted to current and former U.S. Military Personnel, who have been designated "Qualified in Submarines" by authorized U.S. Navy Command Authority, or are regular members of the U.S. Submarine Veterans of World War II.

Section 3. LIFE MEMBERS

- A. Regular Members may become Life Members by paying the National Life Membership Fee established in the Organization's Bylaws. (C2012-1)
- B. National Life Members will pay no further National dues, but may be required to pay Base dues as per Base Bylaws.
- **C.** A Base may offer a member, who is a National Life Member, Base Life Membership, not to exceed the cost of National Life membership.

Section 4: HOLLAND CLUB

- A. Any Regular Member in good standing who has been designated "Qualified in Submarines" for fifty (50) years or more is eligible to become a member of the Holland Club within the organization.
- B. Holland Club members are subject to National and Base Dues to the same extent as other Regular Members of the organization. Holland Club members inducted prior to the effective date of this change (date) are 'grandfathered' and will continue to be designated as National Life Members, but they may be required to pay Base dues as per Base Bylaws.
- C. Holland Club member's membership cards will be appropriately stamped HOLLAND CLUB on the front.
- D. The members of the Holland Club will elect Holland Club officers including a Holland Club Chairman who will represent them directly to the organization's National Commander.
- E. The Membership Chairman will periodically review ALL MEMBERS for eligibility and initiate the admission process as Members become eligible, including a notification to the Holland Club Chairman.

 F. If the Holland Club Chairman position becomes vacant due to death, incapacity or resignation, the National Commander will appoint an interim Holland Club Chairman, subject to confirmation by the National Board of Directors, to serve until the next scheduled meeting of the national Holland Club.

(C01-10)

Section 5: ASSOCIATE MEMBERS

- A. An Associate Member is a person who is not eligible for regular membership but is sponsored by a Regular Member and meets one of the following requirements:
- a. A Regular Member may sponsor a family member (no limit) up to two degrees of consanguinity (blood line relationship) of a regular member, including adoptive children of the regular member.
- b. A Regular Member may sponsor one additional non-family related member for Associate Membership who has demonstrated a strong interest and support of the US Submarine Service by their deeds or actions and is at least sixteen years of age, subject to prior approval by the National Membership Chair. c. A Regular Member may also sponsor one additional non-family related U.S. Military service member, Active or Veteran, for Associate Membership, who has demonstrated a strong interest and support of the US Submarine Service by their deeds or actions, subject to prior approval by the National Membership Chair. If separated from service, it must have been under honorable circumstances.
- d. Some examples of interest and support: Submarine Book author, Sub Tender service, Intel Rider, Museum submarine docent, Submarine Historian or provides some other demonstrated service to advance the US Submarine force, subject to prior approval by the National Membership Chair.
- B. Each Associate Member must be continuously sponsored by a Regular Member in good standing C. Associate Members are eligible for National and Base Annual Membership, and must also retain their membership in an established base to maintain their national USSVI membership. Member At Large status is not available to Associate members.
- D. Associate Members may vote on Base matters (if permitted by Base Bylaws) and may hold elective Base offices of Secretary and/or Treasurer (if permitted by Base Bylaws.) but are ineligible to vote in the National/Region elections and cannot hold National elected office.
- E. An Associate Member must have a Regular Member in good standing as a sponsor at all times to be a member of USSVI. In the event an Associate (Please go to Page 22)

Member's sponsor cannot or will not continue to sponsor the Associate Member (i.e. the sponsor is transferred or leaves the organization), another Regular Member may assume sponsorship of the Associate Member. If no other member will assume the sponsorship, the Associate member will be dropped from membership. If the sponsoring member goes on Eternal Patrol, another Regular Member or the base itself may assume the sponsorship of the Associate Member, but if no other member or the Base will assume the sponsorship, the Associate member will be dropped from membership.

- F. If the Associate Member is the widow, widower, child or grand-child of a deceased Regular Member who was in good standing at the time of death, another regular member or the deceased member's Base may automatically assume the sponsorship.
- G. Current Associate Members in good standing at the time of this section change are 'grand-fathered,' which means they will retain their membership status even though they may not meet the new requirements. (C2012-1)

Section 6. MEMBERS-AT-LARGE

- A. The Base or National Membership Chairman may place any member, who once chooses, or is assigned to a Base, and who is a National Life Member or whose National annual dues are current, but whose Base dues are in arrears, in a category of Member-at-Large.
- B. Members-at-Large whose National Annual dues are current or who are National Life Members will retain National benefits (i.e. receipt of National magazine and voting on National issues).
- C. A Member-at-Large may affiliate with a Base at anytime by remitting Base dues.
- D. A Regular base member may transfer to Member At Large Status at any time by making a request to his affiliated base or to the National Membership Chair.




