

Holland Club Member in the Spotlight—Jim Hanks



This month's Holland Club Member of the Month is James (Jim) Hanks of Great Falls, South Carolina. Here is Jim's story:

Jim grew-up a small town just south of Champaign, Illinois called Tolono were his Father was a farmer. Jim graduated from Tolono High School in 1959 and knew his was bound to be drafted. He headed to Champaign to looking for the Air Force recruiter, knowing he did not want to join the Army. He found that the Air Force had taken a long lunch (go figure), but the Navy recruiter was more than willing to talk to him (seems they always are). This recruiter was good and talked Jim not only into the Navy, but into Nuclear Power School, a guaranteed A school, and into submarines in one sitting. So in early 1960, Jim did his boot camp in San Diego.

After boot camp, Jim was sent to "MM" A School in Great Lakes followed by Submarine School in New London, CT. From Subschool. Jim was sent to the USS Swordfish SSN -579 to qualify as before going to Nuclear Power School. Being a Nuke, this came as a real surprise to me, as I was telling Jim, about a year prior to me, they quit sending Nukes to Sub School. The reason for this was that Nukes would "party" all week long and still pass the tests, since they had moved the Sub School to after Nuke Power School and Prototype, the Nukes knew how to take the tests and pass without must study time. Jim earned his Dolphins on the Swordfish after almost a year and then went on to attend Naval Nuclear Power School in Mare Island. After Mare Island, it was on to Nuclear Prototype School in Ballston Spa, New York. This is some hard training here. Believe me, It was 12 days on 7 day shifts until you qualified and if you fell behind the curve, it was 14 hours a day. I know, I did some 14 hours days a few shifts and failed my first qualification board: and as an Instructor and LPO had to assign students to

these hours when I re-

turned from sea. But Jim struggled also and was one of the 8 to 10 percent that did not make it in each class; many of times those who had a taste of the fleet were the ones who just wanted to escape the BS of nuclear power and get back to being a MM. I had many of my friends do that and I thought many times about doing it myself, the boats needed good "A" gangers too. So it was off to the USS Sailfish, SSR-572, in New London for Jim. I asked Jim why he got out of the Navy. His answer was that at the time he was married and he wife did not want any part of the Navy. Jim enjoyed his submarine service and would have stayed in the Navy if that wife at the time would have not convinced him to get out. Jim's first year out of the Navy he did home appliance repair a job just right for a former A-ganger. Then Jim found a better position with General Electric as a Maintenance Supervisor in Schenectady, NY for 17 years. After that, Jim owed a restaurant for about 4 and half years. Then decide to come to Rock Hill for about 12 year then to Great Falls. He worked for several

chemical companies and did even did some security work. Now retired, Jim says he just does nothing.

Jim after being qualified in Submarines for over 50 years, you have earned the right to do just nothing, but we hope that you have the time some.

Turkey Tetrazzini



While turkey tetrazzini is traditionally baked, you can omit the final step and simply toss the hot pasta and shredded turkey with the sauce and serve.

Ingredients

8 ounces whole-wheat penne or fusilli

1 cup low-fat (1%) milk

sliced

1/4 teaspoon cavenne pepper

1/4 cup grated Parmesan cheese

1-1/2 cups reduced-sodium canned chicken broth

3 tablespoons flour

1 red bell pepper, cut into 1/2-inch squares 8 ounces fresh shiitake mushrooms, stems discarded, caps thinly

1/4 teaspoon salt

8 ounces cooked turkey breast, shredded (2 cups)

- 1. Preheat the oven to 400°F. In a large pot of boiling water, cook the pasta according to package directions. Drain, reserving 1/3 cup of the pasta cooking water.
- 2. Meanwhile in a large saucepan, whisk the broth and the milk into the flour until smooth. Stir in the bell pepper, mushrooms, salt, and cayenne. Cook over medium heat, stirring constantly, until the sauce is slightly thickened and the bell pepper is tender, about 5 minutes.
- 3. Transfer the sauce to a large bowl and add the drained pasta, reserved pasta cooking water, turkey, and Parmesan.

Still Tasty Update 02 Refrigerated Shelf Life

Knowing how long basic foods remain edible can reduce both the waste of food and your money. The Natural Resources Defense Council says the average American throws away between \$28 to \$43 in the form of about 20 pounds of food each month. ... About two-thirds of household waste is due to food spoilage from not being used in time, whereas the other one-third is caused by people cooking or serving too much. Fortunately, many staple food items last much longer than you would expect. Sick of grilled cheese for lunch? Those individually wrapped slices of American cheese will keep in the fridge for a month or two. But while frozen foods are said to keep indefinitely, that does not mean they'll remain at top quality and be palatable. If you have a question about a particular item's shelf life in your freezer or fridge, StillTasty at http://

www.stilltasty.com offers a handy "Keep It or Toss It?" feature. Just type in your query or check their listings of pretty much any food or drink imaginable and the magic timing will pop up. The site also explains how to properly store foods to get the best results.

While most of us smell and visibly inspect foods suspected of being past their prime, experts say the absence of mold or foul odors is not a clear indication that an item remains edible. "You cannot see, smell or taste many harmful bacteria, so although the food may look 'safe' to eat, it is not. When in doubt, throw it out," Weill Cornell Medical College says. In general, leftovers should be eaten within three or four days. The Mayo Clinic says that after a few days, the risk of contracting food poisoning increases. If you don't think you'll be able to eat leftovers within four days, freeze them immediately, the clinic suggests. With that in mind, let's take a look at the shelf life of some basic food groups in the refrigerator and in the freezer:

Breads

- Tortillas, sold refrigerated one to two months in the fridge; three months in the freezer.
- White bread five to seven days in the pantry (not the fridge); three months in the freezer.
- Unbaked homemade cookie dough — one or two days; four to six months.

Dairy

- Butter one to three months in the fridge; six to nine months in the freezer
- Hard cheeses four weeks if opened; six months.
- Soft cheeses one week; six months.
- Milk seven days;
 one month.
- Yogurt two to three weeks; one to two months.

Meats

• Raw ground beef –

one to two days in the fridge; three to four months in the freezer.

- Steaks three to five days; six to 12 months.
- Lean fish one to two days; six months.
- Fatty fish one to two days; two to three months
- Whole chicken or turkey – one to two days; one year. If it's cut into pieces before freezing, the parts should be used within nine months.

Fruits and vegetables -

The National Center for Home Food Preservation says most fruits and vegetables can last from eight months to a year if packaged correctly and frozen at or below 0 degrees.

- Bananas five to seven days in the fridge after they're ripe; two to three months in the freezer
- Lemons one to two months; three to four months.
- Broccoli two weeks; eight to 12 months.
- Carrots four to five weeks; eight to 12

months.

Miscellaneous

- Leftover pizza three to four days in the fridge; two months in the freezer.
- Tuna salad three to five days in the fridge.
 Tuna salad does not fare well in the freezer,
 FoodSafety says.
- Opened bottle of Champagne — three to five days in the fridge.
 Freezer time is not applicable.

Veteran Service Organizations Update 02 ► IRS Targeting VSOs

In the face of reports that The American Legion and other veterans service organizations (VSOs) are being targeted by the Internal Revenue Service, delegates to the Legion's national convention in Houston recently passed three resolutions that include calling for Congress to look into the IRS' field investigations into Legion posts chartered under 501(c)(19) or nonprofit – status.

Auditors with the IRS reportedly are starting to fine Legion posts around the country for not keeping records of veterans' DD-214s, the separation document given by the military to prove honorable service, or other valid documentation. The DD-214 reveals Social Security numbers. dates of birth and, in some cases, places of birth and medical information. The American Legion and IRS do not need this information: the information may be "blacked out" and a copy filed by the post. The Legion and the IRS only need your name, dates of service and character of service. Documents with this information need to be kept securely. Legion members still serving in the U.S. Armed Forces won't receive a DD-214 until they are discharged.

Without documentation group could face a \$1,000 fine each day they aren't in compliance, and they could lose their nonprofit status. Legion Post 447 in Round Rock, Texas, was fined \$12,000 for lack of compliance before finding documents to satisfy inspectors; the IRS said it can't comment on individual taxpayers or organizations. As a result, national convention delegates passed three resolutions regarding the IRS:

Resolution 62 seeks an

amendment to Section 501(c)(19) of Title 26 U.S. Code to either remove the minimum percent of veterans in the post or to provide clarifying language that the minimum percentage be based upon the aggregate enrollments based on the entire national organization of the VSO, rather than on a local community-based post.

Resolution 63 calls for Congress to rectify the problems with Chapter 4.76.26.1 of the IRS Exempt Organizations Examination Guidelines regarding wartime service periods.

Resolution 64 calls for Congress to rectify problems with Chapter 4.76.26.2.2(2)b. of the Jan. 27, 2011, IRS Exempt Organizations Examination Guidelines so it shall provide for at least 75 percent of the members of which are past or present members of the U.S. Armed Forces and substantially all of the other members of which are individuals who are cadets or are spouses, widows, widowers, ancestors, or lineal descendants of past or present members of the U.S. Armed Forces, and that all of its members are either members of a veterans post or organiza-

tion who are related to a member of such post or organization.

Legion posts must maintain a list of members and the category of membership (veteran, degree of relation or nonveteran or nonrelative). If a post receives deductible contributions, it must also maintain a list of members, their dates of service, whether they are war veterans and, if not, whether they are spouses, widows, or widowers of war veterans, veterans or cadets. Legion posts and departments have been in compliance and have kept appropriate records, and in good faith, with these directives as set forth by the IRS, and the Legions feels it is being wrongly targeted by the IRS, and is being held to arbitrary and capricious requirements that are inconsistent with IRS's own publications. Lawmakers agree. Since the reports surfaced, Sen. Jerry Moran (R-KS) and Rep. Jeff Miller – chairman of the House Committee on Veterans Affairs – both have written letters requesting that the IRS respond to complaints its inspectors are asking posts to provide discharge papers or service records during reviews of their taxexempt status. "Even after they return home from war, veterans in America continue to fight battles," Moran said in a letter to Acting **IRS** Commissioner Danny Werfel. "Many struggle to find a job, face difficulties accessing quality health care services, or wait senselessly long periods of time for their benefits claims to be processed by the federal government. The last thing veterans should have to worry about is their privacy within veteran service organizations, or the ability of those organizations to endure seemingly arbitrary IRS audits and the severe financial penalties that could ensue. This news is deeply concerning to me and the thousands of veterans I represent in Kansas."

Miller also wrote a letter to Werfel. "Congress has already provided for the tax exempt status of many veterans' organizations in recognition of both the selfless service of their members and the important role VSOs play in honoring, remembering and assisting some of the most vulnerable and worthy among us – wounded warriors, disabled veterans, military families, and the widows, orphans, survivors, and dependents of the fallen," Miller said in a statement. "Allegations that VSOs are now being unfairly targeted by the very government they sought to protect and defend are nothing short of unacceptable to me." eBay Scams ► How to Avoid

Thinking about selling electronics or other valuables on eBay? Be sure to watch out for this scam. Using a few tricks, scammers fool sellers into shipping goods without receiving payment.

How the Scam Works:

- 1. You list an item on eBay. For this example, let's say it's a laptop.
- 2. Someone purchases

it, and, in addition to the official notification email you get from eBay, you also receive a message from the buyer. In this email, the buyer claims he has an emergency and needs the laptop immediately. He may say it's his son or daughter's birthday gift. In other cases, the buyer claims to be in the military, and he's shipping out in a few days. The buyer may also ask you to send the item to an unconfirmed address, often in another country.

- 3. You reply and agree to send the item that day... as soon as you have confirmation of payment.
- 4. The next email you receive appears to be from PayPal. It looks like a message confirming the buyer's payment. But before you ship the laptop, you log into your PayPal account and check the transfer history. The buyer never sent the money, and the "PayPal" email was a fraud!

How to Spot an eBay Buyer Scam:

Check the buyer's profile. It's important that a buyer's profile shows posi-

tive feedback, a history of eBay use and their location. However. this isn't a guarantee that the buyer is legitimate. Scammers often hack into eBay accounts and use them to bid. Then, they request that the item be shipped to another address.

- Make sure the email is really from PayPal. Read the email carefully, and check that the "sender" address is really from an "@paypal.com" domain. Also, hover over URLs in the message to make sure they link to the real PayPal website
- Watch out for bad grammar and misspellings. Official company emails, such as notifications from PayPal or eBay, aren't filled with typos and awkward English. Poor grammar is a sure sign the email is a fraud.
- Log into PayPal directly. Before you ship

an item, always confirm payment by logging into PayPal and checking your account. Go to the URL directly. Don't use a link from the buyer's email.

• Contact PayPal:

Fraud Target: Senior Citizens ► Reasons

Senior Citizens especially should be aware of fraud schemes for the following reasons:

- Senior citizens are most likely to have a "nest egg," to own their home, and/or to have excellent credit—all of which make them attractive to con artists.
- People who grew up in the 1930s, 1940s, and

1950s were generally raised to be polite and trusting. Con artists exploit these traits, knowing that it is difficult or impossible for these individuals to say "no" or just hang up the telephone.

- Older Americans are less likely to report a fraud because they don't know who to report it to, are too ashamed at having been scammed, or don't know they have been scammed. Elderly victims may not report crimes, for example, because they are concerned that relatives may think the victims no longer have the mental capacity to take care of their own financial affairs.
- When an elderly victim does report the crime, they often make poor witnesses. Con artists know the effects of age on memory, and they are counting on elderly victims not being able to supply enough detailed information to investigators. In addition, the victims' realization that they have been swindled may take weeks—or more likely, months—after contact with the fraudster. This extended time frame makes it even more difficult to

remember details from the events.

Senior citizens are more interested in and susceptible to products promising increased cognitive function, virility, physical conditioning, anti-cancer properties, and so on. In a country where new cures and vaccinations for old diseases have given every American hope for a long and fruitful life, it is not so unbelievable that the con artists' products can do what they claim.

Lost Boats— USS Seawolf SS-197



USS Seawolf (SS-197), a Sargo-class submarine, was the second submarine of the United States Navy named for the seawolf. Her keel was laid down on 27 September 1938 by the Portsmouth Navy Yard in Kittery, Maine. She was launched on 15 August 1939 sponsored by Mrs. Edward C. Kalbfus and commissioned on 1 December 1939, Lieutenant Frederick B. Warder (Class of 1925) in command. After fitting out, Seawolf departed Portsmouth, New Hampshire on 12 April 1940 for her shakedown cruise, which lasted until 21 June and took her as far south as the Panama Canal Zone. Seawolf was next assigned to the Pacific Fleet, home ported at San Diego. In the autumn of 1940, she proceeded to Manila Bay and operated from the Cavite Navy Yard. When war with Japan began, the submarine readied for sea and was on her first war patrol from 8–26 December 1941 Seawolf hunted Japanese

shipping off San Bernar-

dino Strait. On 14 December, she fired a spread of torpedoes at *Sanyo Maru* in Port San Vicente. One torpedo hit, but did not explode. She promptly underwent her first depth charge attack but suffered no damage. *Seawolf* departed Manila on 31 December 1941 for Australia and arrived at Darwin on 9 January

She loaded 30-40 tons of .50-caliber antiaircraft ammunition for use by American forces on Corregidor and sailed for Manila Bay on 16 January. The submarine sighted seven Japanese freighters accompanied by four destroyers and a cruiser on 21 January, but had no opportunity to fire any of the eight torpedoes that she had aboard. The ammunition was unloaded on 28–29 January at Corregidor. Seawolf then loaded torpedoes and passengers, and headed for Surabava, Java. Seawolf sailed out of Su-

Seawolf sailed out of Surabaya on 15 February and began patrolling in the <u>Java Sea</u>-Lombok Strait area. On 19 February, she fired four torpedoes at two Japanese freighter-transports in the Badung Strait. Damage to one was not ascer-

tained, but the other was reported last seen down by the stern and listing to starboard. (However, *Sagami Maru* had been damaged by USAAF air attack, not by *Seawolf*'s torpedo.)

A week later, she fired her stern tubes at a freighter and watched one hit forward of the bridge before going deep to evade depth charges from an escorting destrover at which she had also fired. In March, Seawolf was hunting between Java and Christmas Island. On 1 April, she stealthily approached the anchorage at Christmas Island where the Japanese invasion force lay at anchor. Seawolf fired a spread at Naka. Though Seawolf was credited with a sinking at the time, only one torpedo hit, causing significant damage to the ship, although not harming any of the crew Naka was forced to return to Japan for repairs and was out of the war for almost a year. Unaware she had hit her target, Seawolf then underwent 7½ hours of depth charge attacks. On 1 April, she attacked two cruisers. A violent explosion was heard, but no flames were seen.

Seawolf ended her patrol on 7 April at Fremantle and received the Navy Unit Commendation. On her fifth patrol, from 12 May until 2 July (a total of 51 days at sea), Seawolf patrolled the Philippine Islands area. She attacked freighters on 20 May 23 May, 12 June 13 June 15 June. and 28 June. On 13 June, she fired at two ships and her crew heard four explosions, but no sinkings were confirmed. Seawolf returned to Fremantle for three weeks before beginning her sixth war patrol. Seawolf prowled the

Sulu Sea and Celebes Sea from 25 July – 15 September. She attacked a tanker on 3 August, sank *Hachigen Maru* on 14 August and Showa Maru 11 days later. She returned to Fremantle to refit and then hunted in the Davao Gulf area from 7 October – 1 December. Seawolf sank Gifu Maru on 2 November, Sagami Maru the next day, and Keiko Maru on 8 November. She ended her patrol at Pearl Harbor en route to the West Coast. Seawolf arrived at Mare Island on 10 December 1942 and underwent an

24 February 1943. She returned to Pearl Harbor on 13 March, and on 3 April stood out for another patrol. She ended this patrol early, on 3 May, because she had expended all torpedoes on enemy shipping near the Bonin Islands. On 15 April, she torpedoed Kaihei Maru, sank an old destroyer now known as Patrol Boat Number 39 on 23 April: and sank two 75-ton sampans with her 3-in (76mm) gun. Seawolf returned to Midway Island for refitting and departed that island on 17 May and headed for the East China Sea. She ran into several large convoys as she prowled from Formosa to Nagasaki. The submarine tracked a convoy of 11 ships and fired a spread of torpedoes at a large freighter on 6 June. One torpedo hit the target but proved to be a dud, and another passed under the freighter and hit an escort. Two weeks later, she fired a spread at four ships. One was hit in the stern and sank in approximately nine minutes. This was *Shojin Maru* loaded with troops. Seawolf returned to Midway Island on 8 July and, four days later, steamed

overhaul that lasted until

into Pearl Harbor. Her next patrol was from 14 August – 15 September. This patrol, in the East China Sea, was also ended prematurely due to firing all torpedoes. She sank 12,996 tons of enemy shipping, excluding two 75-ton sampans sunk by shellfire. Seawolf made contact with a sixship convoy on her third day in the patrol area. She attacked day and night for three days before finally surfacing to sink Fusei Maru with her deck gun.

On *Seawolf*'s 11th patrol, in the South China Sea from 5 October – 27 November, she sank Wuhu Maru, Kaifuku Maru, and damaged a 10,000-ton cargo ship. The submarine refitted at Pearl Harbor, and on 22 December 1943, headed for the East China Sea on what was to be her most lucrative patrol. She attacked a seven-ship convoy on the night of 10–11 January 1944 and sank three ships totaling 19,710 tons. On 14 January, Seawolf fired her last four torpedoes at two merchant ships in a convoy, damaging one and sinking Yamatsuru Maru. She continued tracking the convoy while radioing its position to Whale. Whale arrived on 16 January and promptly attacked, damaging one ship and sinking Denmark Maru. The next morning, Whale damaged another before action was broken off. Seawolf (Commander Albert Marion Bontier) returned to Pearl Harbor on 27 January and sailed for San Francisco two days later. After undergoing a major overhaul at Hunters Point, the submarine headed west on 16 May. When she reached Pearl Harbor, she was assigned the task of photographing Peleliu Island in the Palau Islands, in preparation for the forthcoming attack on that stronghold. She carried out this mission despite constant enemy air patrols from 4 June – 7 July.

The submarine headed to Majuro for voyage repairs and was rerouted to Darwin. There, she received orders sending her on a special mission to Tawitawi, in the Sulu Archipelago. The submarine approached to within 700 yards of the beach, picked up a Captain Young and took him to Brisbane.

Seawolf stood out of Brisbane on 21 September to begin her 15th war patrol under the command of Lieutenant Commander A.M. Bontier. She reached Manus Island on 29 September, refueled, and sailed the same day carrying stores and Army personnel to the east coast of Samar. Seawolf and Narwhal exchanged radar recognition signals at 0756 on 3 October in the Morotai area. Shortly thereafter, a 7th Fleet task group was attacked by Ro-41. Shelton was torpedoed and sunk, and Richard M. Rowell began to search for the enemy. Since there were four friendly submarines in the vicinity of this attack, they were directed to give their positions and the other three did, but Seawolf was not heard from. On 4 October, Seawolf again was directed to report her position, and again she failed to do so. One of two planes from Midway sighted a submarine submerging and dropped two bombs on it even though it was in a safety zone for American submarines. The site was marked by dye. Rowell's commanding officer knew he was in a safety lane, but, having failed to get word Seawolf was behind schedule, believed there was no U.S. submarine nearby and chose to attack. Rowell established sonar contact on the submarine, which then sent a series of dashes and dots which Rowell stated bore (con't on page 24)

ARTICLE XII - MEETINGS

- **Section 1.** A National Convention will be held on even numbered years and shall be hosted by a Base. A. Bases desiring to host a national convention must
- A. Bases desiring to host a national convention must place their bid, in the form of a written proposal, four years prior to the National Convention they wish to host, for purposes of adequate planning.
- B. The written proposal must be submitted to the Board of Directors, via the National Senior Vice-Commander at least thirty days prior to the Base's presentation to the membership for vote at the next Annual Business Meeting.
- C. Should there be multiple bids; a vote will be conducted on the floor of the business meeting to determine the Host Base, date and the location.
- D. Should there be no bid by a Base, the Board of Directors shall have the option to host the National Convention using professional operatives.
- E. The locations and time periods for National Convention sites may be pre-determined by the Board of Directors to best meet the needs of the organization's membership
- **Section 2.** An Annual Business Meeting, open to all members in good standing, shall be held during the National Convention
- **Section 3:** The Board of Directors shall meet immediately following the Annual Business Meeting of members and at such other times as the Board of Directors may determine.
- **Section 4:** Regions and Districts may hold meetings as Regional Directors or District Commanders deem necessary.
- **Section 5:** Local Bases must conduct at least one meeting per fiscal year to retain their Charter.
- **Section 6:** All meetings of this organization, whether they are by Base, District, Region, or National will observe a moment of silence in memory of our departed shipmates. **(C2-10)**

Bylaws (continued from September issue)

ARTICLE V -- DUTIES OF OFFICERS Section 8. APPOINTED OFFICERS

The Constitution identifies several positions to be filled by appointment by the National Commander as follows:

- A. National Parliamentarian: The National Parliamentarian is a consultant who advises the National Commander and other officers, committees, and members on matters of parliamentary procedure. The National Parliamentarian shall be appointed and confirmed in accordance with the USSVI Constitution. Desirable qualifications for this position are:
- 1. Relevant experience, such as Chairman or Parliamentarian of an organization, council, committee, or board.
- 2. Good working knowledge of Robert's Rules of Order.
- 3. Good working knowledge of the USSVI Constitution and Bylaws.
- 4. Membership in the National Association of Parliamentarians.

The duties of the National Parliamentarian shall include, but not be limited to:

- 1. Attend National Conventions, Annual Business Meetings and other meetings as may be requested by the National Commander. [The National Parliamentarian is customarily seated next to the National Commander at all such meetings to facilitate rendering procedural advice.]
- 2. Provide advice upon request to all Elected National Officers, Regional Officers and Committee Chairmen on matters regarding the parliamentary procedures of USSVI.
- 3. Assist Base and District Commanders upon request in resolving issues pertaining to USSVI parliamentary procedures as they affect their operations after FIRST consulting with their respective Regional Director regarding same.
- 4. Prepare and deliver a "Turn Over" file to his relief, containing all information and correspondence relating to his office.
- B. Other Appointed Officers: The desirable qualifications and duties for other National Appointed Officers identified in the Constitution shall be as mutually

determined and agreed upon by the National Commander and the appointed officer. In each case, the appointed officer shall prepare and deliver a "Turn Over" file to his relief, containing all information and correspondence relating to his office. (B5-10).



no resemblance to the existing recognition signals. Believing this an attempt to jam her sonar, *Rowell* attacked with Hedgehog. The second attack was followed by underwater explosions, and debris rose to the surface.

Post-war examination of Japanese records shows no attack listed that could account for the loss of Seawolf. While it is possible Seawolf was lost to an operational casualty or as a result of an unrecorded enemv attack, it is more likely she was sunk by friendly fire. 62 officers and men as well as 17 Army passengers were lost. She was the thirty-fourth U.S. submarine lost in the Pacific War, the second (after Dorado in the Caribbean) to friendly fire. On 28 December 1944, Seawolf was declared overdue from patrol and presumed lost. She was stricken from the Naval Vessel Register on 20 January 1945. Seawolf received 13 battle stars for World War II service. She ranked fourteenth in confirmed tonnage sunk (71,609 tons) and tied for seventh in confirmed ships sunk (with Rasher and Trigger), according to the JANAC accounting postwar

The contributions and sacrifices of *Seawolf* and her crew are officially commemorated in Seawolf Park, located on Pelican Island, just north of Galveston, Texas.
