
Subject: South east District Convention




Chaplin's Corner



During World War II (1939-1945), the Battle of Normandy,

which lasted from June 1944 to August 1944, resulted in the Allied liberation of Western Europe from Nazi Germany's control. Codenamed Operation Overlord, the battle began on June 6, 1944, also known as D-Day, when some 156,000 American, British and Canadian forces landed on five



beaches along a 50-mile stretch of the heavily fortified coast of France's Normandy region. The invasion was one of the largest amphibious military assaults in history and required extensive planning. Prior to D-Day, the Allies conducted a large-scale deception campaign designed to mislead the Germans about the intended invasion target. By late August 1944, all of northern France had been liberated, and by the following spring the Allies had defeated the Germans. The Normandy landings have been called the beginning of the end of war in Europe.

The Normandy American Cemetery, overlooking Omaha Beach and the English Channel, was established on June 8, 1944, as the first U.S. cemetery in Europe during World War II. It holds the graves of more than 9,300 U.S. servicemen who died in the D-Day invasion or subsequent missions.


We have much for which to be thankful to all the men and women who fought against evil and won the victory.

home, at night while she sleeps ra-



Middle Eastern Couscous & Chicken Salad

Couscous is small beads of pasta from North Africa, where it is served like rice. Couscous can be "cooked" by steeping it in boiling water or broth for just 5 minutes.

•1/2 cup chicken broth	1 small cucumber, peeled and diced
•2/3 cup couscous	1 small red onion, finely chopped
•1/4 cup (not oil-packed) sun-dried tomatoes, cut into small bits	1/4 cup mint sprigs, finely chopped
•2 cups coarsely shredded cooked chicken breast	2 tablespoons red wine vinegar
•2 cups shredded Romaine lettuce	2 tablespoons extra-virgin olive oil
•1 large carrot, shredded	1 teaspoon ground cumin
•1 cup minced flat-leaf parsley	3/4 teaspoon salt

In small saucepan, combine broth and 1/2 cup water. Cover and bring to a boil over high heat. Stir in couscous and sun-dried tomatoes; cover and let stand 5 minutes.

Spread couscous and tomato mixture on a jelly-roll pan and place in freezer for 2 minutes to chill slightly. Transfer to salad bowl.

Add chicken, lettuce, carrots, parsley, cucumber, red onion, mint, vinegar, oil, cumin, and salt; toss to mix.



High School Designers Tackle Albacore Park

High School designers tackle Albacore Park

PORTSMOUTH – Winners of the New Hampshire Chapter of the American Institute of Architects, AIANH, 2014 High School Design Competition presented their projects recently to the Board of Directors of the USS Albacore Museum in Portsmouth.

This year's project was to design a Submarine History Center for Albacore Park to provide for the continued display of the USS Albacore, to serve as a vessel to honor submarine history in New England, and to display their unique Naval artifacts. It was a purely theoretical design program developed by AIANH for New Hampshire students and with the permission of Albacore Park, however, the design and program requirements do not necessarily reflect the desires of Albacore Park.

Students who won awards in the competition presented their design solutions to the Albacore Museum directors on May 15.

They were: Ian Farr-Szep and Patrick Joseph from Con-Val High School (First Place, Overall); Tori Kort from Pinkerton Academy (Second place, Overall); Matt Demio from Pinkerton Academy (First Place, Graphic Presentation); and Tim Tamulonis from Milford High School (Special Citation for architectural thinking).

Rolfe Voltaire, instructor from Pinkerton Academy, discussed student Jacque Greazzo's project (Second Place, Model).

The presenters showed models and display boards and described their projects. The students were given specifications for their design, which included the following: Design a one-story structure of no pre-determined height, but

respectful of the surrounding environment and complementary to the buildings' function and design. Assume the existing Visitor's Center will be demolished. Include an entrance, information desk, submarine plaque wall, gift shop, staff office, exhibit space, the USS Albacore submarine display, a small theater, restrooms, utility closet, mechanical spaces, exhibit and display support rooms, and outdoors, a memorial garden and parking. Students were given specific building needs and a site plan.

Other winners in the program, who could not attend the presentation, were: Mason Westover, ConVal Regional High School (First Place, Graphic Presentation); Isaac Williamson, Milford High School (working with Tim Tamulonis); and Andrew Husson, Pinkerton Academy (working with Tori Kort).

Jurors for the program were Sheldon Pennoyer AIA, Sheldon Pennoyer Architects, Concord; Bart Sapeta, Associate Professor, Keene State College Architecture Department; and Susan Phillips-Hungerford AIA, Susan Phillips-Hungerford Architect, Peterborough.

The AIANH High School **Design Competition gives** students a fun and challenging opportunity to develop their skills and to learn about the various aspects of architectural planning and design. The program increases awareness of the relationships between space, human scale and function; provides experience in recognizing the various challenges in planning and designing indoor and outdoor spaces for specific uses; exercises analytical abilities and creativity in solving problems; and gives experience in communicating planning and design ideas using scale drawings and models.

India SSN not ready for sea

Contrary to Claims, Arihant Not Prepared For Sea Trials

NEW DELHI: Contrary to claims, India's first indigenous nuclearpowered submarine INS Arihant is still not ready for sea trails, a stage critical for testing the vessel's systems and weapons before it can be commissioned into the Navy.

Arihant's miniaturised nuclear reactor, built with Russian help, had gone critical in last August and since then the 6,000-tonne vessel has been put through a series it will successfully comof harbour acceptance trials, which could take a few more months, according to top navy sources here.

The vessel, powered by a 83-MW pressurised light-water reactor operated with enriched uranium fuel, was to sail out for sea trials earlier this year, but the Navy has not been able to take the vessel out, as more tests are being conducted to ensure foolproof sea trials of all systems on board, sources said.

The vessel going out to sea trials is critical for India to test its homegrown submarinelaunched ballistic missile with nuclear weapon capability. The DRDO has already developed and successfully tested from a submerged pontoon a missile code-named Bo5, but called in popular parlance as K-15, having a 750-km range.

Once Arihant goes for the sea trials and does a six-to-eight months of testing of systems, it will also get to fire the Bo5, 12 of which will be carried by the vessel. The DRDO has maintained that its missile is ready and is awaiting the Arihant to fire it and validate the nuclear triad.

The DRDO is keenly awaiting that moment, as plete India's nuclear triad -- the capability to launch nuclear-capable ballistic missiles from surface, air and undersea platforms.

The nuclear triad is critical for the country for a credible deterrence against a nuclear attack, considering that it has a stated 'no first strike' nuke doctrine.

India currently operates Russian-origin nuclearpowered INS Chakra submarine, leased from Russia in 2012 for use by the Navy for 10 years for nearly `5,000 crore, primarily to gain experience in operating such a

platform, considering that it plans to have a fleet of at least five such indigenous vessels in its fleet in the immediate future

India has maintained that its nuclear submarine fleet strength will be dictated by the maritime security dynamics of the Indian Ocean region and the extended neighborhood.

The USSVI online voting booth is now open to all Regular members (US Submarine Qualified).

The Candidate's statements and the Various Proposed Amendments to the Constitution and Bylaws are printed in The American Submariner. Please read them carefully and then vote for the candidate of your choice and vote to approve or reject the Proposed Amendments.

To vote online in the 2014 USSVI election, go to WWW.USSVI.ORG. When you get there, click on the green [VOTE NAT ELECTION] button (in the upper left corner). This will take you to the login page.

1. Enter your login name and password.

2. If you do NOT know your login info, CLICK the Red [GET PASSWORD] button and answer the questions there. (Last Name, First Name, Date of Birth, 3 digit hull number of your first qual boat)

This will, in turn, take you to the ballot page. When you get to the ballot page, make your choices accordingly and then cast your ballot.

The ballot is also printed in The American Submariner magazine. To vote using the paper ballot, remove the appropriate page from the magazine, mark your votes, include your name and Base on the ballot and send it to the Election Master at the address printed on the ballot. Make sure you include your name and Base, otherwise your vote will not count.

You can also download a copy of the ballot from the web site. Go to the USSVI web site, click on the green "Documents" button (lower left side) and then click on Elections. The ballot for the 2014 election will be available for you to download. Complete the ballot and send it to the Election Master.

A word to Base Commanders: you may print as many copies of the ballot as you require and bring them to A word to Base Commanders: you may print as many copies of the ballot as you require and bring them to your Base meetings between now and when the election closes. Members may complete their ballots at the Base meeting. However, each member MUST complete HIS OWN ballot in his own hand. Members may assist other members, but each member must complete his own ballot.

Also, you may bring a computer to your Base meeting for the convenience of members to vote online during the meeting. However, as before, each member must log in himself and complete his own ballot.

As a reminder, the USSVI Constitution does not allow "proxy" voting. Proxy voting means that one member casts a ballot for another member. The election Master will reject such ballots.

Finally, the electronic voting booth will remain open until August 28, 2014. If you are mailing your ballot, it MUST arrive at the Election Master no later than August 28 as well. If you're mailing your ballot, make sure you mail it out early enough to reach the Election Master by that date.

Military Retirement System Update 03: (con't)

Military Retirement System Update 03:

Once again, the military retirement system is coming under the scrutiny of budgeters and deficit reduction task forces. This time the assault comes from various fronts – from outgoing Secretary of Defense Robert Gates and incoming Secretary Leon Panetta to Vice President Joe Biden. Earlier this vear Gates stated. "Everything is on the table" for budget cuts. Panetta used the same line during his recent nomination hearing before the Senate Armed Services Committee. urging more significant, program-specific changes rather than an acrossthe-board, salami-slice budget cutting approach. Tasked by President Obama with finding over \$400 billion dollars in savings over the next 10-12 years, Gates has become a bit more specific on where some of the savings may be achieved specifically the military retirement system. Gates has criticized the "one-size-fits-all" 20vear retirement structure and has directed the Defense Science Board to establish a working group to develop alternative options. In his final hearing before the Senate Appropriations Committee last week, he noted, "70-80% of the force does not stay until retirement but leave with nothing," endorsing an early vesting system.

Even more ominous, multiple media reports have indicated military retirement cutbacks could be in play in ongoing deficit-reduction talks between administration and congressional leaders, headed by Vice President Joe Biden. Most current proposals are based on recommendations of the 2009 10th Ouadrennial Review of Military Compensation (QRMC), which included:

□ Converting to a civilianized 401(k)-style system under which full retired pay wouldn't be paid until age 57-60

□ Authorizing the services to make variable annual retirement contributions depending on changing retention and skill requirements

□ Vesting retirement benefits after 10 years of service

The last major revision to the military retirement system was in 1986 when Congress passed the so-called REDUX system as part of an earlier budget-cutting drill. REDUX entailed far smaller cuts than the QRMC envisions. Under that plan, post-1986 en-

trants were to receive 40% of high-three-year average basic pay (vs. 50%) at 20 years of service. In contrast to the advocacy of current Defense leaders, then-Secretary Caspar Weinberger warned Congress that REDUX cuts would cause serious future readiness problems by undermining retention. He was proven right. A little over a decade later, Congress had to repeal **REDUX** when the Joint Chiefs of Staff complained it was hurting career retention. And that was in peacetime. Think what you will about the 20-year retirement system, the Military Officers Association of America believes it's the primary reason retention hasn't imploded over the last 10 years of unprecedented strains on career servicemembers and their families. The problem with proposals to cut overall military retirement costs while also implementing an expensive new 10-year vesting plan is that there's only one place for that money to come from - the pockets of those who stay for a full career

If you tried to build a plan to slash career retention, it's hard to conceive a better way than taking lots of money from people who serve a career in order to pay more to people who separate early. Imagine the impact if the QRMC proposals were in effect in today's wartime environment. A 10-year soldier facing a fourth or fifth combat deployment would have a choice between (a) taking the vested military retirement and leaving to pursue a civilian career or (b) having to serve decades longer (with who knows how many more deployments) before being eligible for military retired pay at age 57-60. What do you think would happen to retention then? Especially knowing the ser-





vices let very few people serve that long – but force nearly all out of uniform



Northern Fleet Gets New Nuclear Attack Submarine

Attack submarines have historically played an important role in the great game of undersea cat-andmouse that the U.S. and Russia have engaged in since the dawn of the Cold War.

Russia's newest nuclear powered attack submarine joined the Northern Fleet on Tuesday, signaling an important milestone in the ongoing modernization of Russia's deteriorating Soviet-era fleet.

After the white and blue cross of the Russian Navy's flag was raised over the submarine's bow at a dockside ceremony celebrating the ship's induction into the fleet, Admiral Viktor Chirkov, the head of the Navy, praised the new vessel for its novel characteristics, such as the ability to launch cruise missiles vertically, its improved stealth capabilities, and its advanced command and control systems, ITAR-

Northern Fleet gets a new Boat!

Tass reported Tuesday. Bearing the name of the city in which the submarine — the first of Russia's new-generation Yasen-class boats was constructed, the Severodvinsk is the lead boat of its class. With three additional vessels slated to follow her, the Yasen-type submarines will phase out the older Soviet-era Akula and Alfa-class attack submarines.

Attack submarines have historically played the role of "hunter-killer" in the great game of undersea cat-and-mouse that the U.S. and Russia have engaged in since the dawn of the Cold War. In this role, one of their main functions is to shadow the other side's larger nuclear submarines — the so-called "boomers" that lurk silently in the ocean depths, waiting to launch a flurry of nuclear missiles at their enemy's homeland — and, if necessary, sink the missile carriers with impunity. The Yasen submarines are one facet of Russia's two-pronged submarine modernization drive begun under President Vladimir Putin. Russia also has been developing a new class of boomer. known as the Boreiclass, which will phase out the behemoth, 175meter Typhoon class

missile boats — the largest submarines ever built

Two Borei-class submarines have already been completed and put to sea, and another two are being built. Russia's defense establishment hopes that together, the Yasen and Borei-class submarines will revive the Russian Navy as a player on the high seas, after it lost much of its naval might to neglect and decay during the turbulent 1990s.

But even in withered form, the remnants of the old Soviet Navy could never be written off — In Summer 2012, a Russian Akula-class submarine was able to infiltrate the Gulf of Mexico and patrol restricted U.S. waters for over a month without being detected by the U.S. Navy.
