Old Business

2023 – 24 Submarine Veterans Scholarship. - The United States Submarine Veterans Inc. and the United States Submarine Veterans Charitable Foundation have sponsored educational scholarships for nearly 4 decades. These scholarships, given to submarine veterans and their families, have had a huge impact on their continuing education. The program has expanded eligibility this year. This expansion includes vocational training, trade schools, and apprenticeships for submarine veterans, their children, and grandchildren. The application period for the next academic year is open now.

2023 USSVI and Base Dues. – As of Oct 29th, dues collection has been going very well. To date, there are only 16 Annual Primary Base Members that I have not yet received their 2023 dues payment. **Dues collection Complete**

Joe Clark Scholarship Fund. – Motion was made to transfer \$1000 from the base to the fund. Motion passed. Action complete.

USSVI Charitable Foundation Hurricane Fund. – USSVI CF has established a Hurricane Fund to aid those US Submarine Veterans who were caught in the path of Hurricane Ian. To date \$35,000 dollars has been collected. A motion was made for the base to contribute \$300 to fund. Motion passed and Action Complete.

Standing Donation to Legion Post 55. Motion was made to authorize this as an automatic payment from base. Motion passed and Action Complete.
